Language Highlight – Thlopthlocco Tribal Town



Hesci omvlkatskat! 'Hello everyone!' Thlopthlocco Tribal Town received an Emergency Native Language Project grant, which is being utilized to increase conversational Mvskoke ability among our youth through intergenerational means, which is mainly through summer camps. The focus of each camp is to utilize our Mvskoke language as much as possible, while also

incorporating cultural activities. The language component of the 2022 camp used language through daily language lessons with accompanying presentations/activities. The cultural component of the camp included stickball, Mvskoke hymns, and food preparation. We also had various art forms such as sewing, finger weaving, and storytelling.



For the 2023 camp our focus was the same, but we also included our Mvskoke fluent speakers. The language component of the 2023 camp focused on teaching the campers a version of an important Mvskoke lullaby, Pipē Nocv 'Sleep Baby' and the story Lucv Hopoyet Ayvnks 'He went looking for turtles.'. This story was inspired by the lullaby. A fluent speaker attended the camp each day, so the campers could hear the language being spoken. This was to encourage them to



continue learning the language. The cultural component of the camp included learning about dyeing with natural items, like plants and flowers. We also brought in other cultural activities like using blow guns and making corn husk dolls. As we continue to prepare for our 2024 camp, we continue to make sure our beautiful Mvskoke language is at the forefront of each camp. Mvto! to ANA for allowing us to share our story.
