FFY 2019 Initial and Updated Reports Adoption Savings Highlights

The Children's Bureau has compiled key data from each title IV-E agency's most recent report of Adoption Savings, as reported on the agency's Form CB-496 Part 4 submission. Some highlights of the FFY 2019 Adoption Savings reporting include:

- All sixty-four (64) state and tribal title IV-E agencies required to submit a report for FFY 2019 did so. Fifty-seven (57) title IV-E agencies calculated Adoption Savings using the CB Method (with 14 using sampling and 43 actual amounts). Seven (7) title IV-E agencies calculated Adoption Savings using an Alternate Approved Method.
- These 64 title IV-E agencies reported calculating a national total of **\$298,996,149** in Adoption Savings associated with **57,267** children for the reporting period. These numbers represent an increase from FFY 2018 reported data of about **34%** for both categories.
- A cumulative calculated national total of **\$841,399,894** in Adoption Savings was reported through FFY 2019. These amounts are for FFY 2015 thru FFY 2019.
- A national total of **\$165,796,944** in Adoption Savings funds was reported as expended in FFY 2019. These expenditures are of funds calculated in any of FFYs 2015 – 2019. The largest portion of these expenditures (43.0%) was for Post-Adoption or Post-Guardianship Services. Expenditures for Other Title IV-B or Title IV-E Allowable Services comprised the next largest category at 42.6% of the total. The FFY 2019 expenditures represent an increase of **3.3%** from amounts reported in FFY 2018.
- A cumulative expenditure national total of **\$495,973,379** in Adoption Savings funds was reported through FFY 2019. These amounts are from calculated Adoption Savings for FFYs 2015-2019.
- The remaining cumulative reported calculated Adoption Savings that were unexpended as of the close of FFY 2019 is a national total of **\$345,426,515**. These funds must be expended in a future FFY.

Information on each title IV-E agency's FFY 2019 calculated Adoption Savings is contained in Table 1 and the FFY 2019 expenditure information in Table 2, shown below.
