TO: State Agencies and Indian Tribes Administering Title IV-B, subpart 1, Child

Welfare Services and subpart 2, Family Preservation and Support Services.

SUBJECT: June 30, 1997 Submission of the Annual Progress and Services Report (APSR)

> Required for Title IV-B of the Social Security Act (the Act) and the CFS-101. Annual Budget Request and Annual Summary of Child and Family Services

Forms.

Note: This Program Instruction (PI) applies to States applying for title IV-B, subparts 1 and 2 funds and Indian Tribes that are eligible and applying for title IV-B, subparts 1 and 2, or title IV-B, subpart 2 only funds. A separate PI is being issued to provide guidance to Indian Tribes eligible and applying only

for title IV-B, subpart 1 funds.

Title IV-B, subparts 1 and 2 and Title IV-E, Section 477 of the Social Security LEGAL AND Act; Section 106 of the Child Abuse Prevention and Treatment Act, as RELATED REFERENCES:

amended (42 U.S.C. 5101 et seq.); 45 CPR 1357; ACYF-PI-CB-95-12; ACYF-PI-CB-95-23; ACYF-IM-CB-97-01; ACYF-PI-NCCAN-97-01.

OVERVIEW:

This PI informs States and Indian Tribes of the actio'ns they must take to receive their title IV-B and CAPTA allotments. The actions States and Indian Tribes need to take will depend upon whether they have consolidated title IV-B Plans or not. There have been several legislative and regulatory changes in the past two years that impact the requirements for the title IV-B Child and Family Services Plan (CFSP) (see ACYF-PI-CB-95-12, ACYF-PI-CB-95-23, the Final Rule on title IV-B published in the Federal Register on November 18, 1996 and ACYF-PI-NCCAN-97-01 for additional information). This PI summarizes these changes and provides instruction on what States must do to comply with the title IV-B State Plan requirements in this APSR and all subsequent APSRs.

The legislative and regulatory changes that have impacted the title IV-B CFSP and the APSR requirements include:

- The Child Abuse Prevention and Treatment Act (CAPTA) Amendments of 1996 (Public Law 104-235). This requires the submission of a CAPTA State Program Plan. This Plan is required for States to receive their CAPTA Basic State Grant (BSG) allotment and must be submitted every five years. The statute mandates that the CAPTA Plan be coordinated "to the maximum extent practicable" with the title IV-B State Plan.
- The Final Rule on Title IV-B. Child and Family Services published in the *Federal Register* on November 18, 1996. This final rule amends existing regulations concerning comprehensive child and family services under titles IV-B (Child and Family Services) and IV-E (Federal Payments for Foster Care and Adoption Assistance) of the Social Security Act. This regulation also requires the inclusion of the CAPTA BSG information in the CFSP.
- o <u>Section 554 of the "The Multiethnic Placement Act of 1994" CMEPA</u>). This creates a title IV-B, subpart 1, State Plan requirement, under section 422(b)(9)(first occurrence) of the Act, to facilitate identification and recruitment of foster and adoptive parents who reflect the ethnic and racial diversity of children for whom foster and adoptive homes are needed.
- o <u>The Social Security Act Amendments of 1994.</u> This amended section 422(b) by adding paragraph (10) that requires States to include in the title IV-B, subpart 1, State Plan a description of the specific measures taken by the State to comply with the Indian Child Welfare Act (ICWA).

PART V: Guidance to Indian Tribes newly eligible for fiscal year 1998 title IV-B, subpart 2,

funds that are applying only for title IV-B, subpart 2, funds

PART 1: BACKGROUND

Consolidated CFSP and the APSR

On December 18, 1996 final regulations for title IV-B, Child and Family Services became effective, which revised Federal regulations under 45 CFR 1355, 1356 and 1357. These new regulations specify, among other things, the requirements that States and eligible Indian Tribes must meet in order to receive funding under title IV-B. Two of these requirements are for States and Indian Tribes to develop a five comprehensive CFSP and to provide subsequent annual CFSP updates through an APSR.

Initially, the Department proposed to require a comprehensive CFSP to be submitted by June 30, 1995 (see Notice of Proposed Rulemaking issued October 4, 1994 (59 FR 50646)). A comprehensive CFSP was to meet the planning and reporting requirements for the title IV-B programs and include information on the Independent Living Program (ILP) and the CAPTA program. In response to comments on this proposal, we relaxed the CFSP requirements to allow for a phased-in approach, i.e., States and eligible Indian Tribes are required to consolidate the planning and reporting requirements for title IV-B and CAPTA and include information on the ILP by June 30, 1997.

In order to meet the consolidated CFSP requirements by June 30, 1997, we are <u>not</u> requiring States and eligible Indian Tribes to submit a new five year CFSP. The information required to complete the consolidation requirement is to be submitted as part of the APSR due June 30, 1997. Many States previously submitted a consolidated CFSP while other States submitted a five year CFSP that met only the requirements for title IV-B, subpart 2. These CFSPs should have included information describing how the State was engaged in comprehensive planning and development of the consolidated CFSP encompassing the continuum of child and family services. The CFSP due for fiscal year (FY) 2000 will be a fully consolidated five-year CFSP which will meet the requirements for both the CAPTA and title IV-B programs for the next five year period.

The process of developing the consolidated CFSP is described in 45 CFR 1357.15. The consolidated planning effort should extend the inclusive, consultative process used to develop the Family Preservation and Support Plan to the continuum of services provided under CAPTA and title IV-B, subpart 1. The information provided on title IV-B, subpart 1, should not be considered a separate independent plan. The process of planning, coordination, consultation, and goals and objectives setting is an on-going process which reaches beyond initial development of the CFSP.

We recognize that the consolidation process is a complex and time-consuming one. Joint planning with the ACF Regional Offices should be structured so that any State concerns regarding CFSP approval can be resolved.

Child Abuse Prevention and Treatment Act Amendments of 1996 (Public Law 104-235)

As stated above, a consolidated title IV-B CFSP, submitted as the APSR, is to include information on the CAPTA program. The CAPTA Amendments of 1996 authorize the annual award of funds to States that submit State Plan every five years and meet certain other eligibility criteria. As a result of this change, we are requiring the consolidation of the title IV-B Plan requirements and the CAPTA Basic State Grant (BSG) Plan requirements with this APSR.

This consolidation is consistent with both the CAPTA Amendments of 1996 and the recently published regulation on the comprehensive CFSP in that the CAPTA amendments mandate that the CAPTA Plan be coordinated "to the maximum extent practicable" with the title IV-B Plan. This consolidation also addresses comments the Department obtained from focus groups and will reduce multiple application processes for the States as well.

A separate PI (ACYF-PI-NCCAN-97-01) was issued on March 12, 1997 to provide States with the criteria for funding under the new CAPTA Plan requirements. States are to refer to that PI as they develop their APSRs for specific guidance on the FY 1997 CAPTA BSG application requirements.

Consolidation of the title IV-B and CAPTA State Plans does not allow for pooled funding among the programs, since separate funding streams and accountability are still required by statute. While the information on the two programs is consolidated into one CFSP, eligibility and funding for the individual programs will be kept separate. Therefore, funding will not be delayed for one program due to potential eligibility issues in the other program.

Independent Living Program (ILP)

The consolidated CFSP must also include information on the ILP. Statutory barriers prevent the Department from requiring the consolidation of the application for the ILP into the title IV-B CFSP. However, States may consolidate the ILP application into the title IV-B CFSP and still meet the requirement in 45 CFR 1357.16(a)(4). States could thereby receive their ILP funds earlier in the fiscal year.

Although consolidation of the ILP application into the title IV-B planning process is encouraged, pooled funding among the programs is not allowed, since separate funding streams and accountability are still required by statute. While the information on the two programs may be consolidated into one Plan, eligibility and funding for the individual programs will be kept separate and funding will not be delayed for one program due to potential eligibility issues in the other program.

·Additional Title IV-B Plan Update Requirements

There have been two amendments to section 422 of the Act. The first amendment created section 422(b)(9)(first occurrence) of title IV-B, subpart 1, of the Act. This section requires the diligent recruitment of potential foster and adoptive families who reflect the ethnic and racial diversity of children in the State for whom foster and adoptive homes are needed. (ACYF-PI-CB-95-23 describes how States must meet this State Plan requirement and provide annual updates.)

The second amendment added section 422(b)(10) to title IV-B, subpart 1, of the Act. States are required to include in the title IV-B Plan a description, developed after consultation with tribal organizations in the State, of the specific measures taken by the State to comply with the Indian Child Welfare Act (ICWA). (See ACYF-PI-CB-95-12 for further clarification on the ICWA requirements for the State Plans and annual updates.)

Now that the State CFSP is to include both of the programs under title IV-B, the requirements discussed above are to be included as part of the CFSP and APSR.

PART II: GUIDANCE TO STATES ON SUBMISSION OF THE APSR

A. Requirements that all States must meet whether or not a consolidated CFSP has previously been submitted.

1. Annual Progress and Services Review. According to 45 CFR 1357.16, each State must conduct an interim review of the progress made in the previous year toward accomplishing the goals and objectives in the CFSP, based on updated information. The State must involve

the agencies, organizations, and individuals who are part of the on-going CFSP related consultation and coordination process. On the basis of this review, each State must prepare and submit to ACF, an APSR which must include the following --

- a. A report on the specific accomplishments and progress made in the past fiscal year toward meeting **each goal and objective**, including improved outcomes for children and families, and a more comprehensive, coordinated, effective child and family services continuum.
- b. Any revisions in the statement of goals and objectives or to the training plan, if necessary, to reflect changed circumstances.
- c. A description of the child welfare, family preservation, family support, and independent living services to be provided in the upcoming fiscal year highlighting any additions or changes in services or program design and including the information required in 45 CFR 1357.15(n).
- d. Information on activities in the areas of training, technical assistance, research, evaluation, or management information systems that will be carried out in the upcoming fiscal year in support of the goals and objectives in the plan.
- e. Information required to meet the maintenance of effort (non-supplantation) requirement in section 432(a)(7) and (8) of the Act.
- f. Any other information the State wishes to include.
- g. The CFS-101 forms are to be submitted with the APSR in order for States to receive their FY 1998 title IV-B allotments. Instructions for the CFS-101 and copies of the forms are attached.

2. CAPTA Plan requirement.

- a. States must include the CAPTA Plan information required for BSG funding in their APSRs due June 30, 1997.
- b. The consolidated planning effort should extend the inclusive, consultative process used to develop the Family Preservation and Support Plan to the continuum of services provided under CAPTA.
- c. States are to follow the instructions in ACYF-PI-NCCAN-97-01.
- d. The information contained in this APSR should encompass 'FYs 1997-1999.)
- 3. ILP information to be included in the APSR.
 - a. States are required to include in the APSR a description of the independent living services to be provided in the upcoming fiscal year (45 CFR 1357.16(a)(4)).

- F-IM-CB-97-01 must be included in the APSR if a State chooses to a consolidate. S c. ILP Program Reports must still be submitted no later than January 1 0 of the year following the end of the fiscal year for which funds were u awarded t 4. Guidance on title IV-B, subpart 1, CFSP updates that are to be included in this APSR and all future APSRs. e a. States are to describe how the MEPA recruitment plan is in d compliance with section 422(b)(9)(first occurrence) of title IV-B. b. States are required to describe future goals and activities they will
- b. States are required to describe future goals and activities they will undertake to improve compliance with ICWA; or address the progress made to date by the State in meeting these goals as required by section 422(b)(10) of title IV-B.
- B. Requirements for States that previously have not submitted a consolidated title IV-B CFSP.
 - 1. In addition to the information in "A" above, States are required to submit the applicable information required in 45 CFR 1357.15 not previously submitted as part of the CFSP that pertains to title IV-B, subpart 1, and describe these services as part of the continuum of child welfare services.
 - 2. States must include the applicable title IV-B, subpart 1, information in the APSR due June 30, 1997.
 - 3. The consolidated planning effort should extend the inclusive, consultative process used to develop the Family Preservation and Support Plan to the continuum of services provided under title IV-B, subpart 1.
 - 4. The information for title IV-B, subpart 1 is to encompass FYs 1998 and 1999.

PART III: GUIDANCE TO INDIAN TRIBES ON SUBMISSION OF THE APSR.

- A. Requirements that all Indian Tribes applying for title IV-B. subparts 1 and 2 must meet whether or not a consolidated CFSP has previously been submitted.
 - 1. According to 45 CFR 1357.16, each eligible Indian Tribe must conduct an interim review of the progress made in the previous year toward accomplishing the goals and objectives in the CFSP, based on updated information. The Indian Tribe must involve the agencies, organizations, and individuals who are a part of the on-going CFSP related consultation and coordination process. On the basis of this review, each Indian Tribe must prepare and submit to ACF, an APSR which must include the following --

subpart 2, funding may submit either an application for planning funds or submit a CFSP for service funds. If an Indian Tribe elects to submit an application for title IV-B, subpart 2, planning funds. there will be no match requirement in the first year of funding. If a Tribe chooses to forego the planning process and submits a CFSP, the Indian Tribe will be responsible for the match requirement for service funding. Attached is a list of Indian Tribes currently receiving title IV-B, subpart 2 funds and those newly eligible for title IV-B, subpart 2 funds for FY 1998. ACF is committed to providing technical assistance to the newly eligible Indian Tribes to assist in the development of the plans and the implementation of these provisions. Indian Tribes should contact the ACF Federal Regional Offices to request any needed assistance.

- A. Requirements for Indian Tribes submitting an application for title IV-B, subpart 2 FY 1998 planning funds
 - 1. Submit, at a minimum, the information in the following sections of 45 CFR 1357.15:
 - (c) Assurances;
 - (d) Description of the planning process that will form the basis of the CFSP;
 - (f)(1) Name of the Indian Tribe applying for funds; and,
 - (k) Description of how the funds will be used to develop the required baseline information.
 - 2. Describe other activities that will be carried out to develop the CFSP and improve service delivery, including activities such as training and technical assistance.
 - 3. Submit the following certifications, which are attached:
 - o Anti-Lobbying and Disclosure form;
 - o Drug-Free Workplace;
 - o Debarment; and
 - o Environmental Tobacco Smoke (Pro-Children Act of 1994).
 - 4. The Indian Tribe may submit the planning application in the format of its choice.
 - 5. The FY 1998 planning funds will be awarded with no match requirement for the first year of funding.
 - 6. Submit an update to the current title IV-B, subpart 1 Tribal plan for FY 1998.
 - 7. Submit the CFS-101 forms with the planning application by June 30, 1997. The CFS-101 forms and instructions are attached.
 - 8. A comprehensive title IV-B CFSP is to be submitted for FY 1999 by June 30, 1998. The CFSP is to include information on the title IV-B programs and meet the applicable requirements of 45 CFR 1357.15, the requirements of 45 CFR 1357.40 and 45 CFR 1357.50.

- B. Requirements for Indian Tribes submitting a CFSP for title IV-B, subpart 2, FY 1998 services fund.
 - 1. A comprehensive title IV-B CFSP is to be submitted for FY 1998 by June 30, 1997. The CFSP is to meet the applicable requirements of 45 CFR 1357.15, the requirements of 45 CFR 1357.40 and 45 CFR 1357.50.
 - 2. The comprehensive CFSP is to encompass FYs 1998 and 1999.
 - 3. Indian Tribes are to describe the goals, objectives and services to be provided under title IV-B, subparts 1 and 2, and describe these services as a part of the continuum of child and family services.
 - 4. Indian Tribes submitting a CFSP are subject to the match requirement for services funding.
 - 5. The CFS-101 forms are to be submitted with the CFSP in order for Indian Tribes to receive their FY 1998 title IV-B allotments. Instructions for the CFS-101 and copies of the forms are attached.
 - 6. Indian Tribes may submit the CFSP in the format of their choice.

Part V: GUIDANCE TO INDIAN TRIBES NEWLY ELIGIBLE FOR FISCAL YEAR 1998 TITLE IV-B, SUBPART 2, FUNDS THAT ARE APPLYING ONLY FOR TITLE IV-B, SUBPART 2, FUNDS.

Starting with FY 1996 additional Indian Tribes were eligible for title IV-B, subpart 2 funds. New Tribes which become eligible for this funding may submit either an application for planning funds or submit a CFSP for service funds. If an Indian Tribe elects to submit an application for title IV-B, subpart 2, planning funds, those funds will be awarded with no match requirement in the first year of funding. If a Tribe chooses to forego the planning process and submits a CFSP, the Indian Tribe will be responsible for the match requirement for service funding. Attached is a list of Indian Tribes currently receiving title IV-B, subpart 2 funds and those newly eligible for title IV-B, subpart 2, funds for FY 1998. ACF is committed to providing technical assistance to the newly eligible Indian Tribes to assist in the development of the plans and the implementation of these provisions. Indian Tribes should contact the ACF Regional Offices to request technical assistance.

A. Indian Tribes submitting an application for FY 1998 title IV-B. subpart 2, planning funds.

 - (c) Assurances:

- 4. The Indian Tribe may submit the planning application in the format of its choice.
- 5. The FY 1998 planning funds will be awarded with no match requirement for the first year of funding.
- 6. Submit the CFS-101 forms with the planning application by June 30, 1997. The CFS-101 forms and instructions are attached.
- 7. A title IV-B CFSP is to be submitted for FY 1999 by June 30, 1998. The title IV-B CFSP is to meet the applicable requirements of 45 CFR 1357.15, the requirements of 45 CFR 1357.40 and 45 CFR 1357.50.

B. Requirements for Indian Tribes submitting a CFSP for FY 1998 title IV-B. subpart 2. service funds.

- 1. A title IV-B CFSP is to be submitted for FY 1998 by June 30, 1997. The CFSP is to meet the applicable requirements of 45 CFR 1357.15, the requirements of 45 CFR 1357.40 and 45 CFR 1357.50
- 2. The CFSP is to encompass FYs 1998 and 1999.
- 3. Indian Tribes are to describe the goals, objectives and services to be provided under title IV-B, subpart 2 and describe these services as a part of the continuum of child welfare services.
- 4. Indian Tribes submitting a CFSP are subject to the match requirement for services funding.
- 5. Submit the CFS-101 forms with the CFSP. The CFS-101 forms and instructions are attached
- 6. Indian Tribes may submit the CFSP in the format of their choice.

SUBMITTALS:

An original and two copies of the APSR, or Planning Application, or CFSP and the CFS-101 must be submitted to the Administration for Children and Families (ACF) Federal Regional Office by June 30, 1997.

CFS-101 INSTRUCTIONS

State agencies administering title IV-B oftheSocial Security Act (theAct) are required to submit an annual budget request and summary of services (CFS-101). Indian Tribal Organizations which meet the requirements for direct payments and administer the programs are also required to submit this information annually.

a) Placement Prevention:

Services to prevent family disruption and unnecessary removal of children from their homes (as appropriate). These services may include intensive family preservation, post-adoptive support services, case management, counseling, day care, respite services. homemaker services, services designed to increase parenting skills, family budgeting, coping with stress, health, and nutrition.

b) Reunification Services:

Services to help children, where appropriate, return to families from which they have been removed or be placed for adoption or legal guardianship. These services may include day care services, homemaker or caretaker services, family or individual counseling for parent(s) and child, follow-up care to families to whom a child has been returned after placement and other reunification services the State identifies as necessary.

4. Foster Care Maintenance:

a) Foster Family and Relative Foster Care:

Payments to cover the cost of, and cost of providing, food, clothing, shelter, daily supervision, school supplies, a child's personal incidentals, liability insurance with respect to a child, and reasonable travel to the child's home for visitation.

b) Group/Institutional Care:

This includes the reasonable costs of administration and operation of institutional/group home care that are necessarily required to provide food, clothing, shelter, daily supervision, school supplies, a child's personal incidentals, liability insurance with respect to a child, and reasonable travel to the child's home for visitation.

5. Adoption Subsidy Payments:

Funds provided to adoptive parents on a recurring and periodic basis to assist in the support of specialneeds children.

6. Administration and Management:

Include costs of supervisors and staff whose activities support child welfare services and which cannot be allocated under other services/activities.

7. Family Preservation and Family Support 10% Administration Cost: (Not applicable to Indian Tribes)

Includes costs of administrative services for family preservation and family support which are not more than ten percent of Federal expenditures under title IV-B, subpart 2 of the plan for the fiscal year. Allowable costs may include, but are not limited to, procurement, payroll processing, personnel functions, management, maintenance and operation of space and property, data

processing and computer services, accounting, budgeting, auditing, and indirect costs allocable in accordance with the agency's approved cost allocation plan (See 45 CFR 1357.32{h)).

8. <u>Significant Portion:</u> (Not applicable to Indian Tribes)
