## Title IV-E Prevention Program Overview

- Revised and reauthorized title IV-B, subparts 1 and 2 of the Social Security Act (Child Welfare Services and Promoting Safe and Stable Families programs)
- Created New title IV-E Prevention Services Program
  - Optional prevention funding under title IV-E
  - Beginning October 1, 2019, states and tribes with an approved title IV-E prevention plan have the option to claim title IV-E for a portion of trauma-informed mental health services, substance abuse services and in-home parent skill-based programs



# First Reporting Period Overview

• IV-E agencies must begin collecting data starting one full FFY following the FFY in which the plan was approved.

FFY 2022	Oct. 1, 2021- Sept. 30, 2022	FFY 2024: Oct. 1, 2023 – Mar. 31, 2024	Apr. 1, 2024 – [May 15, 2024]
FFY 2023	Oct. 1, 2022- Sept. 30, 2023	FFY 2023: Oct. 1, 2024 – Mar. 31, 2025	Apr. 1, 2025 – [May 15, 2025]



## **Submission Window Overview**

• Title IV-E agencies will be required to submit data on all children with a prevention plan on a 6-month (per Federal Fiscal Year) basis with a transmission period of 45 days.

Two 6-month report periods based on the federal fiscal year:	File due dates
Oct. 1 to Mar. 31 (A submission)	May 15
Apr. 1 to Sept. 30 (B submission)	Nov. 14

• Title IV-E agencies will receive notifications from NCWDMS 1 month prior to the submission deadline, 2 weeks prior, and the final day when submissions are due. Title IV-E agencies will also receive a letter to confirm that the CB Data Team has successfully received their submission.

## Ongoing Reporting Period Overview

• The first submissions were received from April – May 2022. Example 6-month submission dates for jurisdictions approved in FY 2020 below.

#### **Revised Technical Bulletin #1**



Publication Date: August 20, 2021

This revised Technical Bulletin #1 provides additional information regarding the file structure for the data elements to be submitted by IV-E agencies for each child who received IV-E prevention services, as required by FFPSA.

#### Resubmissions

Title IV-E agencies may resubmit their data at any time.

#### **Child Level Reporting**

- Reporting services and costs at the child level when it's a service provided to the family requires consideration.
- Multiple candidates in the home receiving similar or different services also requires consideration.
  - An appropriate approach is to take the total service costs and allocate them across the multiple candidates receiving the service.

#### **XML/NCWDMS**

- Some schema errors were found and those have been corrected. Please make sure you are reviewing the most current technical bulletins and reach out to the CB Data Team email if you have questions.
- Some agencies had difficulties navigating NCWDMS. NCWDMS questions can be directed to the NCWDMS
  helpdesk. All agencies can test files in NCWDMS at any time once they have login credentials.

#### **Service Providers**

- Managing data collection from outside service providers can be challenging for a range of reasons.
  - Methods for collecting and sharing service data.
  - Circumstances associated with providing costs data.

#### **Staff Turnover**

- At the agency level, staff turnover led to some confusion around understanding the process for submission.
- At the service provider level, staff turnover created challenges because providers needed clients in order to hire staff, but in some cases, clients would not be sent to them if services couldn't be provided right away.



#### **System Challenges**

- CCWIS development and FFPSA data collection can create competing demands.
  - When program staff and technical staff work closely together, some of these problems are avoided.
  - Developing a data catalog that can be mapped to program goals, reporting requirements, and existing CCWIS data fields could be very helpful.
- Legacy systems at times did not contain the means to extract relevant data,
  i.e., identifying pregnant or parenting youth in foster care, duplicate service
  codes across programs.

#### **Data Quality Challenges**


- Candidates over the age of 18 being reported.
  - This may occur due to extended foster care since youth who remain in extended foster care after the age of 18 are eligible to be candidates.
  - In other instances, this appeared to be errors in the date of birth.
- Service end dates for a candidate that enters foster care
  - If a child enters foster care, they are no longer part of a prevention plan so the service end date for the purposes of FFPSA would be the date they entered foster care.
- Multiple prevention plan service start and end dates
  - Legislation specifies that a prevention plan may only be 12 months. Eligibility may be re-established for an additional prevention plan at the 12 month point and a second prevention plan would begin. Even if the service is still ongoing, the service should end when the prevention plan ends. That same service would have a new start which would be the same day that the second prevention plan starts.
- Foster Care Entry Elements
  - Element 13 asks for foster care status **at** 12 months (not up to the 12-month point), therefore if the prevention plan has not lasted 12 months, "null" should be reported in that field.
