Title IV-E Prevention Program Overview

- Revised and reauthorized Title IV-B, subparts 1 and 2 of the Social Security Act (Child Welfare Services and Promoting Safe and Stable Families programs)
- Created New Title IV-E Prevention Services Program
 - Optional prevention funding under title IV-E
 - Beginning October 1, 2019, states and tribes with an approved title IV-E prevention plan have the option to claim title IV-E for a portion of trauma-informed mental health services, substance abuse services and in-home parent skill-based programs

Status of Prevention Plans (as of 9/17/2021)

Approved (16 plans)

Washington DC, Utah, Maryland, Arkansas, Kansas, Kentucky, North Dakota, West Virginia, Washington State, Nebraska, Iowa, Oregon, Hawaii, Virginia, Maine, Eastern Band of Cherokee Indians

Under Review (18 plans)

Illinois, Colorado, Ohio, Indiana, Missouri, South Carolina, Tennessee, Oklahoma, New Hampshire, Montana, Connecticut, Arizona, California, Nevada, Michigan, Pennsylvania, Aleut Community of St. Paul, Salt River Pima-Maricopa Indian Community

Title IV-E Prevention Program Data Overview

States and tribes electing to provide IV-E prevention services and programs must report the following data to HHS annually for each child:

- The specific services or programs provided and the total expenditures for each of the services or programs
- The duration of the services or programs provided

Additionally, for candidates for foster care:

The child's placement status at the beginning, and at the end, of the 1-year period, respectively, and whether the child entered foster care within 2 years after being determined a candidate for foster care

Reporting Timeline

 IV-E agencies must begin collecting data starting one full FFY following the FFY in which the plan was approved

Submissions

• Title IV-E agencies will be required to submit data on all children with a prevention plan on a six-month (per Federal Fiscal Year) basis with a transmission period of 45 days

Two 6-month report periods based on the federal fiscal year:	File due dates
October 1 to March 31 (A submission)	May 15 th
April 1 to September 30 (B submission)	November 14 th




Reporting Population

- There are two distinct reporting populations that title IV-E agencies must include in their submissions as specifically defined in the law (below)
 - Candidate for foster care
 - Pregnant or parenting youth



Recap

- File submissions are in XML which allows for nesting structure to the data
- Each record contains the information for a child/youth for a particular prevention plan
- As part of each record, we collect information on the services provided <u>as part of</u> the prevention plan for a child/youth
- Records for candidates for foster care can have any number of dates of entry into foster care (within a 24month period)



File Submission

- CB is working with a contractor to provide an enterprisewide engineering and architecture service to support child welfare data management called the *National Child Welfare Data Management System (NCWDMS)* to manage two CB programs
 - AFCARS
 - IV-E Prevention Program Plan




