# Family Violence Prevention and Services Act Program



Since 1984, FVPSA remains the primary federal resource dedicated to provision of domestic violence shelters, supportive services, and related programming for victims of domestic/dating violence and their dependents.



## FVPSA Statutory Purposes

- Assist States and Tribes in efforts to prevent domestic violence and dating violence.
- Provide immediate shelter and supportive services for victims of domestic violence and their dependents.
- Provide for a National Domestic Violence Hotline.
- Provide for technical assistance and training relating to domestic violence and DV programs to States, Tribes, public agencies, community-based programs and the public.
- Provide specialized services for abused parents and their children.

# 2021 ARP COVID-19 Testing, Vaccines, and Mobile Health Units Supplemental Funding Overview

Funding Amount: \$550 million

Purpose: Provision of grants to domestic violence shelters and programs for rapid testing, onsite testing, and providing access to COVID-19 testing; providing access to vaccines; and for facilitating access to mobile health unit services for adult and youth victims of family violence, domestic violence, or dating violence, and their dependents

Type of award: Supplemental award to existing FVPSA grant recipients

Release Date: October 25, 2021

Recipients:

- \$332,500,000 for states representing 56 grant recipients reaching 1,500 domestic violence programs (subaward grants);
- \$142,500,000 for tribes representing 144 grant recipients reaching 252 tribes (direct awards and consortia awards); and
- \$50,000,000 for coalitions, resource centers, capacity building centers and hotlines to provide technical assistance to tribes, domestic violence shelters/programs, and culturally specific organizations.

What is the training and technical assistance vision for the ARP COVID-19 testing, vaccines, and mobile health units supplemental funding?

# Technical Assistance Vision

## Phase 1

Joint webinars; focused technical assistance sessions; and best practices profiles that provide implementation inspiration; share foundational collaboration strategies; and helps grantees connect to existing resources and peers.



## Phase 2

Launch a peer-based innovation lab that includes partnership best practices videos, sample policies, and sample implementation plans that drive the scaling of integrated services for domestic violence survivors in each US state and territory.



## Phase 3

Issue policy and practice briefs to address knowledge gaps; hold policy training sessions; provide policy clarifications; and provide examples of protocols/policies that can be adapted.



# Opportunities for Resource Center Leadership & Partnerships with the FVPSA Program

- **Intentional technical assistance, resources, and capacity building** to help local programs, states, and tribes advance equity for all, including people of color and others who have been historically underserved and marginalized communities.
- **Technical Assistance** to support partnerships with health departments, OHM regional teams, health systems to support the implementation of COVID-19 testing and access to mobile health units.
- **Technical Assistance** to support workforce capacity building and supports for local domestic violence programs, tribes, and culturally specific programs.
- **Facilitate intentional partnership building** between states, tribes, culturally specific organizations, and domestic coalitions to ensure that the needs of American Indians and Alaska Natives, racial/ethnic specific communities are represented in any state planning processes.
- **Identify and promote innovation** to help local programs to drive the scaling of integrated services for domestic violence survivors in their communities.
- **Identify and promote innovations** for prevention programming and service transformations for survivors, culturally specific communities, and American Indian and Alaska Native communities to access social services or are involved with social service agencies.

# ARP Supplemental Funding Technical Assistance Plan

1. Assist states and tribes with the planning of their supplemental applications;
2. Connect FVPSA grantees with peers to learn from experienced colleagues; and
3. Provide Technical Assistance (TA)
  - Webinars;
  - Policy and Practice Briefs;
  - Share Sample MOUs, Organizational Policies/Protocols, and Staff Training Presentations;
  - Hold training of trainers for coalitions, DV program staff, or tribes; and
  - Listening sessions with subrecipients (dv programs, sexual assault programs, rape crisis centers, culturally specific service providers, and tribes).

# ARP Supplemental Funding Ongoing TA Plan

1. Outreach to States, Coalitions and Tribes regarding implementation examples; solutions to challenges; documenting successes; sharing best practices;
2. Provide updates for the innovation lab and online toolkits;
3. Provide real-time examples of ways to use supplemental funding from peers;



# **ARP Supplemental Grants FVPSA Program Reporting Plans**

1. Develop PRA approved quarterly surveys to gather information about the reach, implementation and impact of ARP supplemental funding.
2. Launch and review quarterly ARP surveys to gather information about the reach, implementation and impact of ARP supplemental funding.
3. Streamline ARP reporting for grantees to be one ARP report as opposed to four. Need to develop specific PPR reporting training and guidance for grantees.

# ARP COVID-19 Testing, Vaccines, Mobile Health Units Supplemental Funding Allowable Coalitions Activities

Provide training, technical assistance, and resources/policy development to:

- Assist grantees with planning for the implementation of COVID-19 testing programs, vaccine programs/supports, COVID-19 mitigation programs/strategies, or mobile health units access programs for domestic violence survivors;
- Assist states, territories, tribes, domestic violence programs and culturally specific with implementing programs COVID-19 testing procedures, COVID-19 vaccine programs/supports, COVID-19 mitigation activities, or mobile health unit coordination activities;
- Implement innovative partnerships and pilot programs that will provide domestic violence survivors with access to COVID-19 testing, COVID-19 vaccine programs/supports, COVID-19 mitigation supports, or access to mobile health units to mitigate the spread of the COVID-19 virus;

# ARP COVID-19 Testing, Vaccines, Mobile Health Units Supplemental Funding Allowable Coalition Activities

Provide training, technical assistance, and resources/policy development to:

- Assist states, territories, tribes, domestic violence programs and culturally specific programs with providing supportive services for survivors and coordinating access to preventative health services to mitigate the spread of the COVID-19 virus such as best practices for accessing vaccines, testing, primary health care, or behavioral health services;
- Assist states, territories, tribes, domestic violence programs and culturally specific programs with workforce capacity building and hiring culturally-competent and linguistically-appropriate providers and staff to carry out COVID-19 testing procedures, COVID-19 vaccine programs/supports, COVID-19 mitigation activities, or mobile health unit coordination activities;

# ARP COVID-19 Testing, Vaccines, Mobile Health Units Supplemental Funding Allowable Coalition Activities

- Document and disseminate innovative practices developed by states, territories, tribes, domestic violence programs, culturally specific programs, and coalitions to effectively deliver services remotely, provide COVID-19 testing, coordinate access to vaccines, and partner with mobile health units or in other modes that mitigate the spread of the COVID-19 virus, to include those developed by culturally specific services providers;
- Strengthen partnerships with health care providers, health centers, and health departments to support the ability of states, territories, tribes, domestic violence programs, culturally specific programs and coalitions to implement COVID-19 testing; provide access to vaccines; and coordinate with mobile health units to support domestic violence survivors and their dependents as they mitigate the spread of the COVID-19 virus;

# ARP COVID-19 Testing, Vaccines, Mobile Health Units Supplemental Funding Allowable Resource Center Activities

- Provide training, technical assistance, and resources/policy development for ensuring the safety, sustainability, and capacity building of the domestic violence advocacy workforce during the COVID-19 public health emergency;
- Provide technical assistance on implementing mobile advocacy for domestic violence survivors during the COVID-19 public health emergency and the coordination of COVID-19 testing, vaccine programs/supports, and mobile health unit coordination activities for domestic violence survivors and their dependents; and
- Increase public awareness about best practices for providing access to COVID-19 testing, vaccines, and mobile health units for domestic violence survivors and their dependents, including lifting up best practices that support underserved populations and rural communities in mitigating the spread of the COVID-19 virus and safely support domestic violence survivors.

## FVPSA State Administrators and Tribes ARP COVID-19 Testing, Vaccines, & Mobile Health Units Supplemental Funding Q&A – **Acceptance?**

**Do we have to accept these supplemental funds? No.**

All FVPSA-funded states, territories, and tribes have the option to accept or not accept the ARP COVID-19 testing, vaccines, and mobile health unit supplemental funding.

**Is there a penalty for not accepting these funds? No.**

**Will nonaccepted funds be redistributed? Yes.**

No, there is no penalty for not accepting the supplemental funding. Please note that ARP COVID-19 supplemental funds that are not accepted by grant recipients will be returned to the ACF Office of Grants Management and disbursed to other grant recipients that will need additional funding to implement COVID-19 testing, vaccines, and mobile health units for domestic violence survivors.

## FVPSA State Administrators and Tribes ARP COVID-19 Testing, Vaccines, & Mobile Health Units Supplemental Funding Q&A – **Combine use with other ARP Supplemental Funding**

**Can these funds be used in coordination with the implementation of my agency's or tribe's ARP supplemental award issued on May 20, 2021, to provide services and supports to survivors? **Yes.****

FVPSA grant recipients may use ARP supplemental funding issued in May 2021 in coordination with the ARP COVID-19 testing, vaccines, and mobile health units supplemental funds to provide comprehensive services and supports to meet the needs of survivors and to implement supports related to a range of in-scope activities to assist survivors and their dependents in staying safe, healthy, and healing. ARP supplemental funds allow for flexibility and creativity in how FVPSA grant recipients expand supports to bridge the gaps in services and supports needed to assist survivors and their children.



## FVPSA State Administrators and Tribes ARP COVID-19 Testing, Vaccines, & Mobile Health Units Supplemental Funding Q&A – **Required Allocation Percentages?**

**Are there required percentages for how these supplemental funds can be allocated to provide access to testing, vaccines, and mobile health units for domestic violence survivors? **No.****

FVPSA ARP grant recipients do not have a required percentage range for how much of the ARP supplemental funding needs to be allocated towards testing, vaccines, and mobile health units. FVPSA grant recipients have the flexibility to allocate the ARP COVID-19 testing, vaccines, and mobile health units supplemental funding to provide comprehensive services to meet the needs of survivors and to implement supports related to a range of in-scope activities to assist survivors and their dependents with mitigating the spread of COVID-19 while fleeing violence.

# FVPSA State Administrators and Tribes ARP COVID-19 Testing, Vaccines, & Mobile Health Units Supplemental Funding Q&A – Match?

**Is there a match required for these funds? No.**

No match is required for these ARP supplemental grant awards or subawards.

# FVPSA State Administrators and Tribes ARP COVID-19 Testing, Vaccines, & Mobile Health Units Supplemental Funding Q&A – **End Early?**

**Do we have to use the funds this fiscal year? **No.****

ARP supplemental funds were made available on October 25, 2021 and will remain available until expended and through the end of FY 2025, September 30, 2025.

**Do we have to go all the way up to 2025? **No.****

**Can we propose to end services for this grant earlier? **Yes.****

Activities proposed under ARP supplemental funding may end prior to September 30, 2025. ARP supplemental funding will remain available until expended and through the end of FY 2025, September 30, 2025, but funds may be fully spent down prior to that time. All grantees have the flexibility to use the funds over multiple years based on need.

# FVPSA State Administrators and Tribes ARP COVID-19 Testing, Vaccines, & Mobile Health Units Supplemental Funding Q&A— Competitive Subawards?

**Is it mandated that ARP COVID-19 testing, vaccines, and mobile health units supplemental funding is awarded competitively? Are FVPSA formula funds competitive? No.**

FVPSA supports community-driven solutions to address domestic violence and promotes partnerships amongst FVPSA-funded programs with community-based agencies, services, and supports.

Per the Standing Notice of Funding Opportunity, States determine the method in which funds will be distributed and awarded.

# FVPSA State Administrators and Tribes ARP COVID-19 Testing, Vaccines, & Mobile Health Units Supplemental Funding Q&A– 90-day Distribution of Funds

**For a myriad of reasons, our State office cannot meet the requirement to compete and distribute funds within 90 days of receipt of funding. What are we to do?**

If you are not able to distribute your funds within the 90-day requirement, in your brief statement please explain why funds cannot be distributed within the timeframe required; describe your plan to distribute ARP COVID-19 testing supplemental funds to subawardees as immediately and expediently as possible, including the date by which this will occur, and the process to be used. Grantees will be expected to meet the timeframe established to make an initial disbursement and it should not be later than February 28, 2022.

If the states will provide multiple disbursements over multiple years, then please describe the distribution plan in your supplemental application proposal.

## FVPSA State Administrators and Tribes ARP COVID-19 Testing, Vaccines, & Mobile Health Units Supplemental Funding Q&A – Survivors Mandated to Participate in Testing/Vaccines Services?

**Are survivors mandated to participate in COVID-19 testing or vaccination programs? No.**

No, in accordance with FVPSA statute and regulations, services must be provided on a voluntary basis and no condition may be applied for the receipt of emergency shelter (42 U.S.C. 10408(d)(2)). Further, recipients cannot impose conditions for admission to shelter by applying inappropriate screening methods (45 CFR 1370.10(b)(10)).

# FVPSA State Administrators and Tribes ARP COVID-19 Testing, Vaccines, & Mobile Health Units Supplemental Funding Q&A– **Health Care Partnerships & Collaborations?**

**Can we partner with health care providers to offer testing, vaccines, and mobile health unit services to survivors? **Yes****

All FVPSA grant recipients are allowed and strongly encouraged to establish formal agreements, MOUs, contracts, or interagency agreements with local/state health departments, state agencies, Indian Health Services, health centers, health care providers, mobile health units, and other community based partners in order to provide access to testing, vaccines, and mobile health units for domestic violence survivors, domestic violence programs, tribes, and culturally specific programs in their states and local communities.

# FVPSA State Administrators and Tribes ARP COVID-19 Testing, Vaccines, & Mobile Health Units Supplemental Funding Q&A– **Health Care Partnerships Resources?**

**Are there resources to help us partner with health care providers to offer testing, vaccines, and mobile health unit services to survivors? **Yes****

FVPSA-funded National Health Resource Center on Domestic Violence has developed two resources that can help states, territories, tribes, shelters, programs, and health care providers build and sustain strong partnerships.

# FVPSA State Administrators and Tribes ARP COVID-19 Testing, Vaccines, & Mobile Health Units Supplemental Funding Q&A– COVID-19 Testing Expenses?

## What are allowable COVID-19 testing expenses?

COVID-19 testing, mitigation, and related expenses may include the following:

- COVID-19 testing includes viral tests to diagnose active COVID-19 infections, antibody tests to diagnose past COVID-19 infections, and other tests that the Secretary and/or Centers for Disease Control and Prevention (CDC) determines appropriate in guidance;
- Other activities to support COVID-19 testing, including planning for implementation of a COVID-19 testing program, providing interpreters and translated materials for LEP individuals, procuring supplies to provide testing, training providers and staff on COVID-19 testing procedures, and reporting data to HHS on COVID-19 testing activities; or
- Supplies to provide COVID-19 testing.

# FVPSA State Administrators and Tribes ARP COVID-19 Testing, Vaccines, & Mobile Health Units Supplemental Funding Q&A– COVID-19 Vaccines Expenses?

## **What are allowable COVID-19 vaccine expenses?**

The supplemental funding can be used for supplies and vaccine administration fees for administering the COVID-19 vaccine.

Allowable uses of funds may include, but are not limited to, the development and sharing of vaccine related outreach and education materials that are culturally competent or linguistically appropriate.

FVPSA grant recipients can use ARP COVID-19 testing, vaccines, and mobile health units supplemental funding to contract with businesses to make COVID-19 vaccines, boosters, and essential health services easily accessible for survivors in your state or local community. There are businesses that offer indoor testing, mobile buses, and mobile trailers that can collect tests and administer vaccines in a variety of settings.

## FVPSA State Administrators and Tribes ARP COVID-19 Testing, Vaccines, & Mobile Health Units Supplemental Funding Q&A – **Transfer Grant?**

**Can FVPSA transfer this supplemental award to another state agency? **No.****

No, the FVPSA Program cannot transfer the ARP COVID-19 testing, vaccines, and mobile health unit supplemental grant award to another state agency. All ARP COVID-19 testing vaccine and mobile health unit supplemental grant awards must be issued to existing FVPSA state, territory, and tribal grant recipients.

**Can we partner with other agencies and tribes to implement this supplemental funding? **Yes.****

All FVPSA grant recipients are allowed and strongly encouraged to establish formal partnership agreements, MOUs, or interagency agreements with local/state health departments, state agencies, Indian Health Services, health centers, health care providers, and mobile health units in order to provide access to testing, vaccines, and mobile health units for domestic violence survivors and their dependents.

# FVPSA State Administrators and Tribes ARP COVID-19 Testing, Vaccines, & Mobile Health Units Supplemental Funding Q&A– **Mobile Health Units Expenses?**

## **What are allowable mobile health unit expenses?**

This ARP supplemental funding is intended to assist states, territories, tribes, shelters, culturally specific organizations, and rural communities with establishing or maintaining contracts with existing mobile health units operated by hospitals, medical clinics, health centers, and public health nonprofit organizations.

This funding is intended to provide resources for contractual agreements with mobile health units to make regular visits each week to shelter locations, program locations, transitional housing locations, or tribal locations. FVPSA grant recipients are not expected to purchase or operate their own mobile health units.

# FVPSA State Administrators and Tribes ARP COVID-19 Testing, Vaccines, & Mobile Health Units Supplemental Funding Q&A— Workforce Capacity Building Expenses?

## What are allowable mobile health unit expenses?

Expenses to secure and maintain adequate personnel to carry out COVID-19 testing, COVID-19 mitigation activities, or mobile health unit coordination activities

Please review HHS regulations 45 CFR § part 75 “Uniform Administrative Requirements, Cost Principles, and Audit Requirements for HHS Awards,” Subpart E—Cost Principles, <https://www.ecfr.gov/current/title-45/subtitle-A/subchapter-A/part-75/subpart-E?toc=1>. Such expenses may include:

- Hiring bonuses and retention payments,
- Childcare,
- Transportation subsidies, and
- Other fringe or personal benefits authorized by HHS regulations ([45 CFR part 75](#)).

# FVPSA State Administrators and Tribes ARP COVID-19 Testing, Vaccines, & Mobile Health Units Supplemental Funding Q&A **Direct Cash Assistance**

**Will direct payments to survivors be an option? Has the statutory prohibition on direct payments to survivors been lifted/waived under ARP supplemental funding? **No.****

FVPSA Section 308(d)(1) prohibits direct payments to victims of domestic violence or their dependents, which states, *no funds provided under this title may be used as direct payment to any victim of family violence, domestic violence, or dating violence, or to any dependent of such victim.* Until there is an act of Congress, this prohibition remains in place.

The FVPSA Program does not have the legal authority to waive the direct payment prohibition outlined in Section 308(d)(1) to allow ARP funding to be used to make direct payments to survivors.

# FVPSA State Administrators and Tribes ARP COVID-19 Testing, Vaccines, & Mobile Health Units Supplemental Funding Q&A– **Vehicle Purchases**

**Public transportation has become limited/non-existent. Will we be able to purchase vehicles to support staff travel to areas of service where transportation doesn't exist? **Yes.****

Vehicle purchase is an allowable expense under the FVPSA Program. Motor vehicles are defined as general purpose equipment. Once purchased, the motor vehicle may only be used for specific grant related activities.

Under the FVPSA, grant funds may be used for the “provision of advocacy, case management services, and information and referral services, concerning issues related to family violence, domestic violence, or dating violence intervention and prevention, including ... provision of transportation.”

In order for a grantee to purchase a vehicle, they **will need to obtain prior written approval for the purchase** and ensure that the vehicle is used in support of FVPSA activities, ensuring victims have access to the services they need.

Request additional information from your Federal Program Officer who will assist you in coordinating approval for such request with the ACF Office of Grants Management.

# FVPSA State Administrators and Tribes ARP COVID-19 Testing, Vaccines, & Mobile Health Units Supplemental Funding Q&A—Next Steps

All existing FVPSA grantees must submit a brief statement within 90 days of receiving funding:

- **By February 7, 2022, at 6:00PM ET**, the ARP supplemental funding brief statement must be uploaded at <http://www.GrantSolutions.gov>. This statement verifies that the state agency, tribe, or domestic violence coalition is in a position to: 1) use these funds to provide services for those affected by COVID-19 in accordance with FVPSA; and 2) accept a supplemental award.
- **By February 7, 2022, at 6:00PM ET**, FVPSA formula grantees including states, tribes, and coalitions will need to upload the ARP COVID-19 Testing, Vaccines, and Mobile Health Units Supplemental Funding Budget and Budget Narrative to Grant Solutions (within Online Data Collection System (OLDC) for formula grantees) at <http://www.GrantSolutions.gov>. This budget and budget narrative explain how the supplemental funding will be used. Please note that use of funds must be in alignment with the Allowable Use of Funds for ARP supplemental funding, available at <https://www.acf.hhs.gov/fysb/grant-funding/2021-fvpsa-american-rescue-plan-covid-19-testing-vaccines-and-mobile-health-0>

- **Vaccine Access**—Please discuss your state's, territory's, or tribe's plan to partner with your local health department or IHS to provide domestic violence shelters, domestic violence programs, culturally specific organizations, and rural communities with resources to implement or have access to COVID-19 vaccines for domestic violence survivors and their dependents.

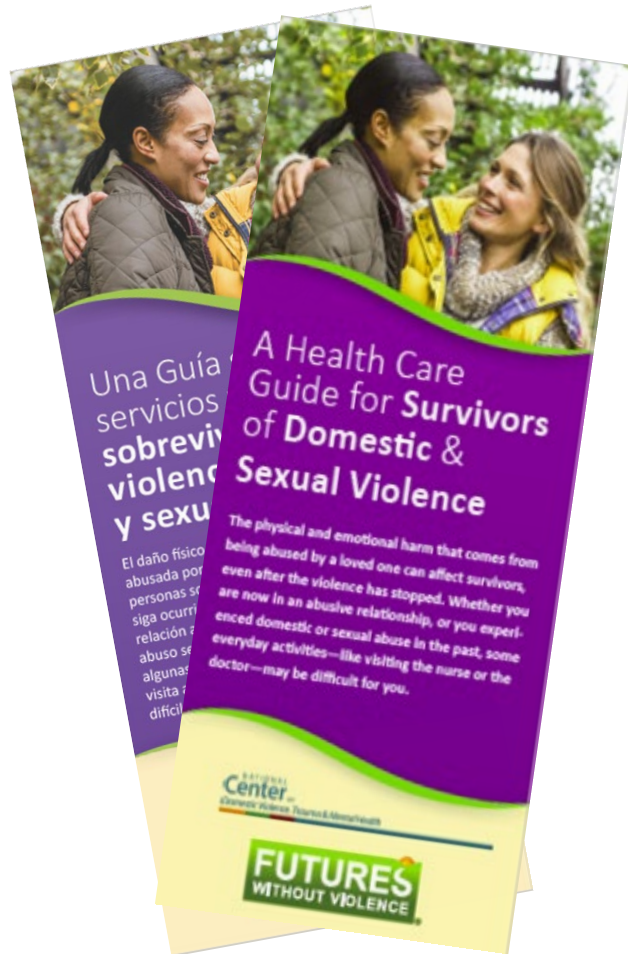
