



Summary of Waiver Approvals

As of September 30, 2021, the Office of Child Care (OCC) concluded the waiver request and approval framework linked to the coronavirus disease 2019 (COVID-19) pandemic. The tables below summarize waiver approvals for states, territories and tribes for all waiver requests reviewed between March 1, 2020 through September 30, 2021.

Cumulative Summary of Approved State and Territory Waiver Requests

This table summarizes the 129 waiver approvals by state and territory and by provision approved as of October 1, 2021. This cumulative table includes all waivers approved to date. New waiver approvals added to this table are in italics (3 new approvals). Waivers previously approved as of August 6, 2021 are not italicized (126 approvals).

The cumulative summary of all waiver approvals for these state and territory requests is:

- (1) 48 states and territories requested and were approved for waivers for fingerprint, National Sex Offender Registry, interstate checks, existing staff backlog, and provisional hire requirements of criminal background checks as fingerprint locations were closed in many states and therefore unable to process requests.
- (2) 36 states and territories requested and were approved for waivers of pre-licensure and annual health and safety inspections. The Centers for Disease Control and Prevention (CDC) has recommended restricting visitor access to child care programs and physical distancing for all Americans at this time, therefore many states opted to postpone or cancel these inspections and restricted the opening of new programs. Many of these states reported conducting visits should they receive complaints about abuse and neglect.
- (3) 35 states and territories requested and were approved to waive copayments for all families. As many families were struggling with income during this time, states chose to remove this economic hardship and opted to pay providers with other means.
- (4) 21 states requested and were approved for waivers of health and safety training requirements as in-person trainings were suspended following CDC guidelines.
- (5) 19 states and territories requested and were approved for waivers related to eligibility, including 18 waivers of the 12-month eligibility period requirement, four waivers of the income eligibility limit for essential workers– as they were unlikely to continue to need assistance with child care for a full 12-month period, three waivers for graduated phase-out, two waivers for asset limits, and one waiver for job search.
- (6) 17 states requested and were approved for waivers of certain health and safety standards, including three waivers for other extended family members (such as cousins, great-nieces and great-nephews) to be exempted from the CCDF health and safety requirements of 45 CFR §98.41, §98.42, §98.43, and §98.44 to provide care for the children and families impacted by COVID-19. When waiver of standards was approved, they were tied to the inability to perform in-person training on the standard. No requests to waive ALL Health and Safety Standards were received.

- (7) 10 states and territories requested and were approved to waive fiscal requirements related to liquidation and obligation funds and percentage requirements for direct services and quality spending.¹
- (8) 10 states requested and were approved for waivers related to consumer and provider education, including posting of monitoring and inspection reports, aggregate data, and the consumer education statement.
- (9) 7 states requested and were approved for waivers related to payment practices, including two waivers in order to pay two providers for the same child, two waivers for market rate survey (MRS), and one waiver for equal access related to rates.

Cumulative Summary of Approved Tribal Waiver Requests

This table summarizes the 148 waiver approvals by tribe and by provision approved as of October 1, 2021. This cumulative table includes all waivers approved to date. New waiver approvals added to this table are in italics (41 new approvals). Waivers previously approved as of August 6, 2021 are not italicized (107 approvals).

The cumulative summary of all waiver approvals for these tribal requests is:

- (1) 69 tribes requested and were approved to waive fiscal requirements related to liquidation and obligation funds and percentage requirements for direct services and quality spending as many tribes were closed and unable to spend any funds.⁶
- (2) 51 tribes requested and were approved to waive copayments for all families. As many families were struggling with income during this time, tribes have chosen to remove this economic hardship and are opting to pay providers with other means.
- (3) 14 tribes requested and were approved for a waiver of health and safety inspections. The Centers for Disease Control and Prevention (CDC) has recommended restricting visitor access to child care programs and physical distancing for all Americans at this time, therefore tribes have opted to postpone or cancel these inspections and have restricted the opening of new programs. These tribes report they will still conduct visits should they receive complaints about abuse and neglect.
- (4) 12 tribes requested and were approved for waiver of certain health and safety standards, including 11 waivers requested for other extended family members (such as cousins, great-nieces and great-nephews) to be exempted from the CCDF health and safety requirements of 45 CFR §98.41, §98.42, §98.43, and §98.44 to provide care for the children and families impacted by COVID-19. No requests to waive ALL Health and Safety Standards were received.
- (5) 9 tribes requested and were approved for waivers for fingerprint, provisional hire, child abuse and neglect registry, and National Sex Offender Registry requirements of criminal background checks as fingerprint locations were closed and therefore unable to process requests.
- (6) 8 tribes requested and were approved for a waiver of health and safety training requirements as in-person trainings were suspended following CDC guidelines.
- (7) 3 tribes requested and were approved for waivers related to eligibility, including two waivers of the 12-month eligibility period requirement and one waiver of the income eligibility limit for essential workers.
