Prior to FY 2015, the number of households assisted with winter crisis assistance or year-round crisis assistance were reported together in the *LIHEAP Household Report*. Beginning with the *LIHEAP Household Report for FY 2015*, states were asked to report the number of households assisted with winter crisis assistance separately from the number of households assisted with year-round crisis assistance. See Appendix A for a copy of the report.

² Includes data for households assisted by two states (Alaska, Massachusetts) that provided winter crisis fuel assistance solely by expediting heating assistance.

³ Includes data for households assisted by one state (Maryland) that provided year-round crisis fuel assistance solely by expediting heating assistance.

⁴ Forty-five states provided weatherization assistance in FY 2015. This total includes states that weatherized households during FY 2015 with funds from FY 2014. Therefore, this total is not comparable to the total number of states that provided FY 2015 weatherization assistance benefits under 'Uses of Funds' (Table I-6).

² A designation of “--” applies to those states that did not provide a separate count for cooling assistance because: 1) their heating assistance household counts include, and cooling assistance counts exclude, households that received combined heating and cooling assistance (California, Nevada), or 2) households received energy assistance with no differentiation made between heating and cooling assistance (Hawaii). These states reported these households under heating assistance.

³ Households in winter fuel crisis situations (Alaska, Massachusetts) or year-round fuel crisis situations (Maryland) were assisted solely through expedited heating assistance. These states reported these household counts under the type of crisis assistance, but reported the funding obligated under heating assistance (Table I-7).

⁴ The national total unduplicated count of households receiving any type of LIHEAP assistance is not available as data were reported incorrectly by two states (Texas, West Virginia). These instances are marked with “NA” as data were not available.

⁵ The following states provided emergency heating/cooling repairs or replacements to households as part of their energy crisis benefits. These households are excluded from the crisis assistance counts from Table III-2: California (3,375), Colorado (1,592), Delaware (2), District of Columbia (61), Idaho (462), Illinois (1,358), Iowa (1,166), Maine (18), Maryland (152), Michigan (976), Minnesota (5,243), Mississippi (1,705), Missouri (192), Montana (562), Nebraska (153), New Jersey (2,924), New York (1,264), North Carolina (1,287), North Dakota (933), Oregon (339), Pennsylvania (8,050), Rhode Island (553), South Carolina (122), South Dakota (544), Texas (3,927), Utah (357), Washington (307), West Virginia (75), Wisconsin (335), and Wyoming (413).

⁶ California’s crisis assistance counts exclude 51 households served with the state’s Severe Weather Energy Assistance and Transportation Services (SWEATS).

⁷ The following states provided nominal benefits for SNAP households and reported the number of households assisted. These households are not included in the household counts in Table III-2: Connecticut, 95,229 - \$20.01 benefits; Delaware, 14,177 - \$20 benefits; Maine, 8,071 - \$21 benefits; Massachusetts, 113,757 - \$21 benefits; Montana, 884 - \$25 benefits or 5% of the amount of a regular LIHEAP benefit; New York, 291,922 - \$21 benefits; Oregon, 48,514 - \$1 benefits (first quarter of FY 2015) or \$21 benefits (remainder of FY 2015); Pennsylvania, 301,213 - \$21 to \$24 benefits; Rhode Island, 67,459 - \$20 benefits; Vermont, 26,558 - \$21 benefits; Washington, 143,603 - \$20 benefits.

⁸ Connecticut’s winter crisis assistance count excludes 16,960 households that also received Safety Net Assistance.

⁹ The District of Columbia obligated funds to year-round crisis assistance, but separated the household count into year-round crisis assistance and summer crisis assistance depending on the month in which assistance was provided.

¹⁰ Michigan’s winter crisis assistance count excludes 96,680 households that received assistance through the Michigan Energy Assistance Program.

¹¹ Nebraska’s year-round crisis assistance counts exclude 1,908 households that received deposit assistance.

¹² Nevada’s year-round crisis assistance count excludes 12 households assisted through the state’s Crisis Intervention Program.

¹³ North Dakota assisted households with non-crisis cooling equipment repair and replacement services using funding obligated to emergency cooling equipment repair and replacement, but reported such households under cooling assistance.

¹⁴ North Dakota reported that it weatherized some households in FY 2015 with LIHEAP weatherization funds obligated but not expended in FY 2014.

¹⁵ South Carolina's crisis assistance counts exclude 382 households that were provided air conditioners and 45 households that were provided blankets. Households receiving year-round fuel crisis bill payment assistance may have also received emergency furnace and air conditioner repair and replacement services.

¹⁶ Texas has not developed effective procedures to develop accurate statistics on the unduplicated count of households receiving any type of assistance. Therefore, these data are suppressed and are indicated as 'NA'.

¹⁷ Washington's winter crisis assistance count excludes 205 households that received Temporary Shelter Assistance and 16 households that received other emergency repairs.

¹⁸ West Virginia was unable to report a reliable unduplicated count of households receiving any type of assistance because the state has not developed effective procedures for comparing LIHEAP fuel assistance recipients with LIHEAP-funded weatherization assistance recipients. Therefore, these data are suppressed and are indicated as 'NA'.

¹⁹ Wisconsin's year-round crisis assistance count excludes 2,384 households that received assistance through the Keep WI Warm Fund.
