# Low Income Household Water Assistance Program

MODOC NATION LIHWAP PROFILE SUMMARY



The Modoc Nation Low Income Household Water
Assistance Program (LIHWAP) is funded at \$10,000 in
FY21. The Modoc Nation LIHWAP provides services to
Modoc Nation Tribal members nationwide who meet income
guidelines and are in need of restoring household water
services, paying water/sewer bills in arrears, and having the
rates charged reduced. The Modoc Nation reported 23
different Tribal member households who required
assistance for shut offs or assistance for arrears for
household water utilities. Within the Tribal service area, the
average amount needed to restore services is \$513 and the
average amount of arrears is \$364.

# **Program Operation**

The Modoc Nation's LIHWAP, which began in December 2021, is managed and operated at the Tribal level. The Modoc Nation LIHWAP provides relief assistance to 3 priority groups:

- Households whose water or wastewater services have been disconnected
- Households facing the threat of disconnection of their water and wastewater services
- Households in need of rate reduction in current bills


- Restoration of services

### Benefits on Behalf of Households

Under the Modoc Nation's administration of the program, eligible households may receive up to \$1,000 in financial assistance to pay the account balance, past due arrears, or disconnection and reconnection fees. Program staff use applicants' income, household size, and drinking water and wastewater burdens to determine the benefit amount. In the case where the maximum benefit (\$1,000) exceeds the max amount benefit, a case-by-case review can occur for the household to receive additional financial support to restore service, that meets program priorities and ensures connection or prevention of disconnection for low-income households.

# **Priority Populations**

Households that meet program eligibility criteria and fall in one of the following categories are prioritized and receive higher eligibility points.

- ✓ People with disabilities
- √ Families with young children
- ✓ Older Adult/Seniors (60+)
- √ Households with high water burden

## **Program Outreach Activities**

- Place posters/flyers in local and county social service offices, offices of aging, Social Security offices, Veterans Affairs, etc.
- Publication of articles or public service announcements in local newspapers or broadcast media announcements.
- Mass mailing(s) to prior-year LIHEAP recipients or recipients of other government benefits.
- Inform low-income applicants of the availability of all types of LIHWAP assistance at application intake for other low-income programs.
