# Low Income Household Water Assistance Program

UNITED TRIBES OF KANSAS AND NEBRASKA LIHWAP PROFILE SUMMARY



The United Tribes of Kansas and Nebraska Low Income Household Water Assistance Program (LIHWAP) is funded at \$10,560 in FY21. The Tribe utilizes LIHWAP grant funds to provide emergency assistance to enable low-income households to access water and wastewater services.

## **Program Operation**

The United Tribes of Kansas and Nebraska's LIHWAP, which began in March 2022, is managed and operated at the Tribal level in coordination with other programs available to low-income households. The United Tribes of Kansas and Nebraska's LIHWAP provides relief assistance to **two priority groups**:

- Households whose water and/or wastewater services have been disconnected
- Households with existing arrearages to prevent disconnection of water and wastewater services



# **PROGRAM COORDINATION**

- One application for multiple programs, i.e., SNAP, Medicaid, TANF, LIHEAP, and LIHWAP
- Intake referrals to/from other programs





#### **Benefits on Behalf of Households**

Under the Tribe's administration of the program, eligible households may receive up to \$750 in benefit assistance.

## **Priority Populations**

Households that meet program eligibility criteria and fall in one of the following categories receive priority assistance.

- ✓ People with disabilities
- √ Families with young children
- ✓ Older Adult/Seniors (60+)
- ✓ Households with high water burden

#### **Program Outreach Activities**

- Place posters/flyers in local and county social service offices, offices of aging, Social Security offices, Veterans Affairs, etc.
- Publication of articles or public service announcements in local newspapers or broadcast media announcements.
- Work directly with water utilities to identify potential recipients.
- Inclusion of inserts in water vendor billings to inform individuals of the availability of LIHWAP assistance.
- Mass mailing(s) to prior-year LIHEAP recipients or recipients of other government benefits.
- Inform low-income applicants of the availability of all types of LIHWAP assistance at application intake for other low-income programs.
