Overview

This technical report uses data from the newly available National Survey of Early Care and Education to provide nationally representative estimates of all home-based care to children ages birth through five years and not yet in kindergarten. About a million paid and an additional 2.7 million unpaid home-based providers are responsible for young children not their own for at least five hours each week.

NSECE analyses use a three-part classification for individuals providing home-based care to children age 5 and under who are not yet in kindergarten. The classification emerges from the study's sampling approach, which achieved comprehensive coverage of all individuals regularly providing home-based care by drawing on two different ways of identifying those individuals. These two sources were 1) state and national lists of early care and education (ECE) providers, and 2) a nationally representative sample of households that were screened for individuals providing home-based care at least 5 hours weekly to children not their own.

- **'Listed'** individuals appear on state or national lists of early care and education services, such as licensed, regulated, license-exempt, or registered home-based providers. States use these terms with varying definitions and attach varying levels of program and professional standards, oversight and monitoring.

NSECE data can describe each person who provides regular home-based care based on whether or not that person has a prior personal relationship with the children he or she cares for. Prior personal relationships could include family, friends, and neighbors, as well as colleagues, acquaintances from church, or other social ties. Overall, 91 percent of listed providers care for at least one child with whom they have no prior personal relationship. This drops to 35 percent among unlisted paid providers. Not surprisingly, individuals providing only unpaid care virtually always have a prior personal relationship to the children they look after.

For each type we describe key characteristics of both the home-based provider him/herself and the services s/he provides. Examples of home-based providers' personal characteristics include age, marital status, education, and motivation. Examples of characteristics of services provided include number of children, relationship of child and caregiver, hours of care, and revenue from early care and education activities. We summarize the findings for each type of home-based provider below.

Approximately 118,000 listed providers care for over 750,000 children ages birth through age five, not yet in kindergarten. The vast majority of listed home-based providers care for at least one child with whom they did not have a relationship prior to giving care. On average, these providers care for about eight children a week in their own home. Almost half consider this work a career and perceive their primary responsibility as meeting children's needs. Almost two-thirds have some education above high school, often in ECE or a related field, although less than a fifth have a bachelor's degree or higher. Three-quarters have recent training and about one-third participate in college courses or coaching. Over three-quarters provide more than 40 hours of care a week. Half spend an additional 10 hours or more per week on related work. For about half of listed providers, child care income constitutes the majority of their household income.

Almost a million (919,000) unlisted paid providers regularly care for over 2.3 million children ages birth through age five. A little more than a third of unlisted paid home-based providers care for at least one child with whom they do not have a prior relationship. On average, they care for about four children in a week in either the provider's or child's home. Less than one in five consider this work a career, and six in ten perceive keeping children safe as their primary responsibility. Almost one in five consider their primary responsibility to be providing nurturing and love. Slightly less than half have education above high school and less than a tenth have done college-level work in ECE or a related field. Less than a fifth have a bachelor's degree or higher. Less than a quarter have participated in recent ECE training and a little more than a tenth have participated in college courses or coaching. Slightly over a third provide care for more than 40 hours per week. Among those caring for at least one child with whom they have no prior personal relationship, half spend an additional four hours per week on related work. Income from ECE constitutes less than half of the total household income for slightly more than two-thirds of unlisted paid providers.

Over 2.7 million unlisted unpaid providers care for over 4 million children ages birth through age five, not yet in kindergarten. Virtually no unlisted unpaid home-based provider cares for a child with whom they do not have a prior relationship. On average, unlisted unpaid providers care for two children each week in the home of either the provider or the child. Over three-quarters list helping children's parents as their primary reason for looking after children while less than one in ten consider it a career or calling. Unlisted providers are the most likely to have other employment, which fits with the small number of children for whom they care. Over half perceive keeping children safe as their primary responsibility while a quarter consider their primary responsibility to be providing nurturing and love. Over half have education above high school, and one in five have a bachelor's degree or higher. A quarter spend more than 40 hours a week providing care. Since these providers are not paid for looking after children, none of their household income comes from ECE.

The group of unlisted paid providers may be composed of subgroups. The characteristics of some of these subgroups appear similar to those of listed providers while others have characteristics appearing more like those of unlisted unpaid providers. It is helpful to keep these within-group differences in mind when viewing the characteristics of unlisted paid providers.

Introduction: Purpose and Approach

About a million paid and an additional 2.7 million unpaid home-based providers are responsible for young children not their own for at least five hours each week. This technical report uses data from the newly available National Survey of Early Care and Education to provide a nationally representative estimate of all home-based care to children ages birth through five years and not yet in kindergarten. The NSECE also includes a nationally representative sample of home-based providers who serve only school-age children. Those providers are not discussed in this report, but tabulations about home-based providers serving school-age children (whether or not they also serve young children) are included in the Appendix Tables.

NSECE analyses use a three-part classification for individuals providing home-based care to children age 5 and under who are not yet in kindergarten. The classification emerges from the study's sampling approach, which achieved comprehensive coverage of all individuals regularly providing home-based care by drawing on two different ways of identifying those individuals. These two sources were 1) state and national lists of early care and education (ECE) providers, and 2) a nationally representative sample of households that were screened for individuals providing home-based care at least 5 hours weekly to children not their own.

No consensus exists on the terms used to describe home-based care. NSECE categories support examination of home-based care without the meanings that are often attached to commonly-used terms. NSECE terms categorize providers by whether or not they appear on a state or national administrative list of ECE providers.¹ Those who do not appear on such a list are further divided by whether or not they are paid to care for children. In contrast, a wide set of terms is used in the field. Exhibit 1 below crosswalks some terms commonly used in the field to describe home-based care with the NSECE categorization. Virtually any categorization will result in overlap and miss some of the nuances of who is actually providing care to whom and for what, if any, payment.

Within the full range of home-based care, family child care draws a lot of attention because of the visible role it plays in early care and education. In the field, the term has commonly been used to differentiate persons engaged in child care as a business from those who provide care to children of family and friends. One distinguishing characteristic of these home-based providers, known as family child care providers, is the inclusion of children with whom they do not have a relationship until the child enters care. These are small businesses that exist to serve community children and families. The NSECE categorization supports estimation of the number and percentage of home-based providers that meet different definitions of family child care.² A basic definition of family child care could include the following characteristics: a) paid to care for at least one child, b) at least one child had no prior relationship to the provider, and c) care is provided only in the provider's home. Virtually none of the unlisted unpaid providers meet this basic definition of family child care since they are not paid. As can be seen in Exhibit 2 below, the vast majority of listed providers (88 percent) have these three characteristics, whereas less than a quarter of unlisted paid providers (22 percent) do. Yet in terms of numbers, almost twice as many of those who meet these three criteria are not on a public list (199,000 unlisted paid versus 104,000 listed).

To further explore the identification of family child care, we add two characteristics that may indicate that a person is operating a business: a) cares for at least four children regularly and b) provides care at least 20 hours per week. Three quarters of listed providers (76 percent) meet this more stringent definition whereas only slightly more than a tenth of unlisted providers (12 percent) do. Despite the differences in *proportions* of listed versus unlisted paid providers meeting the more stringent definition, the *numbers* of listed and unlisted paid providers meeting this more stringent definition of family child care provider are approximately equal.

Some of the findings reported here are available in an NSECE Fact Sheet published in April of 2015.³ In this report we differentiate types of home-based care using the three categories inherent in the NSECE design: listed, unlisted paid, and unlisted unpaid. For each type we describe key characteristics of both the home-based provider him/herself and of the services s/he provides. Examples of home-based providers' personal characteristics include age, marital status, education, and motivation for providing ECE. Examples of characteristics of care provided include number of children, relationship of child and caregiver, hours of care, and revenue from early care and education activities. Each type of home-based provider exhibits some variation, but the substantial diversity within the unlisted paid group suggests the existence of further distinctive subgroups.

DATA

The NSECE is a set of four integrated, nationally representative surveys conducted in 2012. These were surveys of: 1) households with children under 13, 2) home-based providers of ECE, 3) center-based providers of ECE, and 4) the center-based provider workforce. Together they characterize the supply of and demand for early care and education in America and permit better understanding of how well families' needs and preferences coordinate with providers' offerings and constraints. The study is funded by the Office of Planning, Research, and Evaluation (OPRE) in the Administration for Children and Families (ACF), U.S. Department of Health and Human Services.

The NSECE used a multistage probability design and two independent samples. Because the experiences of low-income families are of special interest in public policy addressing early care and education and school-age care (ECE/SA), the NSECE oversampled low-income areas. The study used a provider-cluster approach for sampling all four surveys from the same small geographic areas. This approach allowed the survey to document the interaction of the supply of and demand for early care and education where it occurs—in local communities—while simultaneously capturing data that efficiently construct national estimates.⁴

This report draws from data collected in the NSECE Home-based Provider Survey which was conducted with individuals who regularly provide care in a home-based setting for children under age 13 who are not their own. The Home-based Provider Survey included listed and unlisted providers. Listed home-based providers were sampled from state or national administrative lists of early care and education services. These were primarily licensed or regulated family child-care providers, but other listed home-based providers such as license-exempt providers and providers participating in Early Head Start were also included. In some states, lists included child-care subsidy recipients, but in most states, subsidy receipt alone did not qualify a provider to appear on a state administrative list of ECE providers. The unlisted sample was drawn from an address-based sample of housing units screened for the presence of an adult in the household who regularly cared for children not his or her own at least five hours per week in a home-based setting. Providers appearing on the assembled state and national lists were excluded from the household sample portion of the Home-based Provider Survey. For this report, data are drawn from approximately 1,500 unlisted home-based providers, and more than 3,800 listed providers.

Given the tremendous heterogeneity of individuals and settings eligible for the Home-based Provider Survey, the questionnaire included some accommodations for subgroups of respondents. In addition to the distinction between listed and unlisted, two further distinctions were made within the questionnaire: paid vs. unpaid, and prior-relationship-based vs. non-prior-relationship-based. A home-based teacher/caregiver was classified as “prior-relationship-based” if s/he reported having had a “prior personal relationship” with the families of all children currently being cared for. S/he was classified as ‘non-prior-relationship-based’ if at least one child in the provider’s care had no prior personal relationship to the provider. Some questions were only asked of home-based providers who were ‘non-prior-relationship-based.’ Prior

relationships could be through family, social, or neighborhood connections, or other community-based ties such as work or church.

Overall, 9 percent of listed home-based providers were classified as “prior-relationship-based.” Among unlisted paid home-based providers, 65 percent were classified as ‘prior-relationship-based’. When discussing characteristics that are available only for non-prior-relationship-based home-based providers, we caution that only a minority of paid, unlisted providers are included.

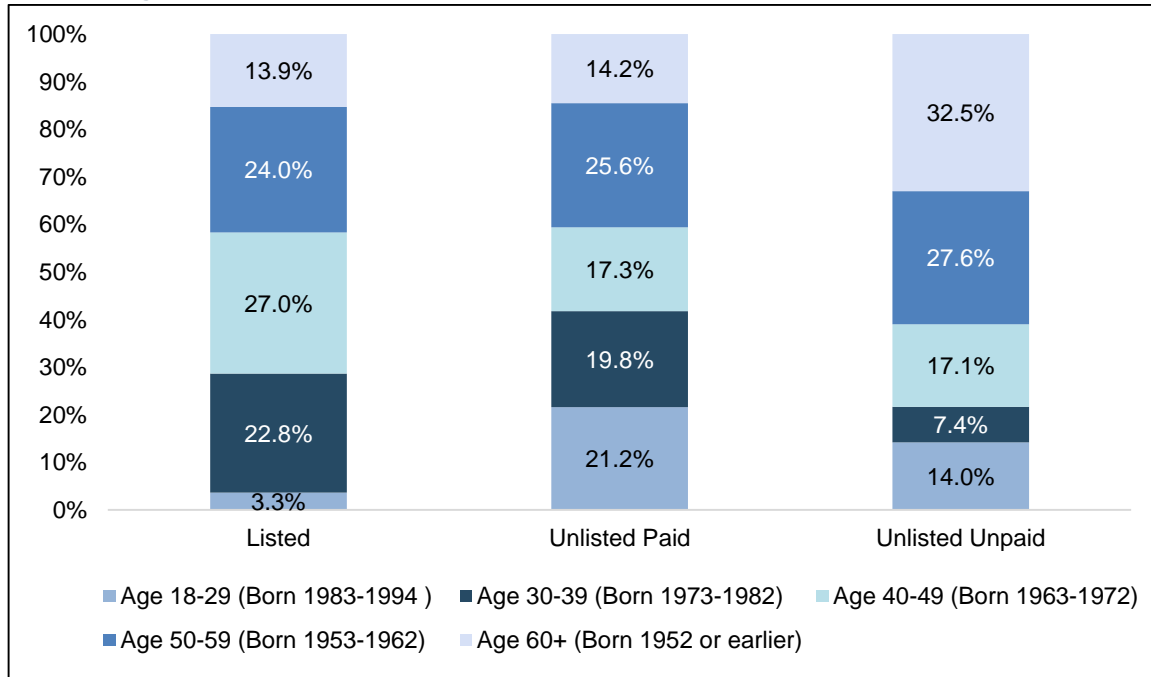
CHARACTERISTICS OF HOME-BASED PROVIDERS

We begin this description of home-based early care and education providers by focusing on the characteristics of the providers themselves. In the next section we will describe the services they provide.

AGE

The majority of home-based providers are between 30 and 60 years of age (74 percent of listed, 63 percent of listed paid, and 52 percent of unlisted unpaid). Listed providers are the least likely to be under age 30 (3 percent compared to 21 percent of unlisted paid or 14 percent of unlisted unpaid). Listed and unlisted paid are both less likely to be 60 years or older (14 percent of each group) than are unlisted unpaid (33 percent). Unlisted paid home-based providers include a higher percentage of young providers than found in listed providers (Exhibit 3).

Exhibit 3. Age of Home-based Providers

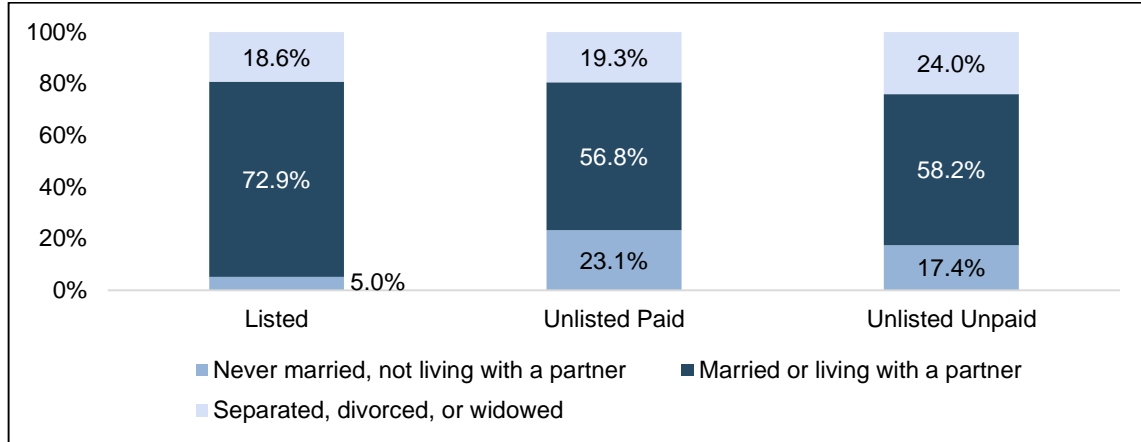

MARITAL STATUS

Listed providers are more likely to be married or living with a partner than are either type of unlisted provider (73 percent compared to 57 percent of unlisted paid and 58 percent of unlisted unpaid). Listed providers are much less likely to have never been married (5 percent of listed vs. 23 percent of unlisted paid and 17 percent of unlisted unpaid) (Exhibit 4).

HOUSEHOLD INCOME

Unlisted paid providers have less household income than do either listed or unlisted unpaid home-based providers (median income of \$24,581 for unlisted paid vs. \$44,870 for listed and \$39,395 for unlisted unpaid) (Exhibit 5).

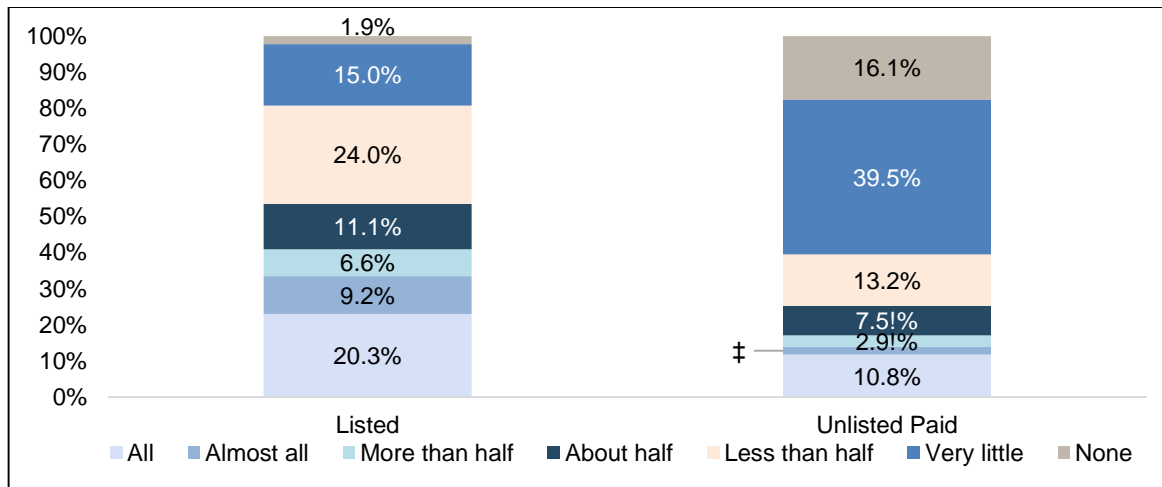

Income from ECE constitutes a bigger percentage of household income for listed than for unlisted paid providers, despite the higher likelihood of two incomes in households of listed providers (since they are more likely to be married). Almost 70 percent (69 percent) of unlisted paid home-based providers earn less than half of their household income from ECE, compared to about 40 percent (41 percent) of listed providers (Exhibit 6).

OTHER PAID EMPLOYMENT

Unlisted unpaid providers are more likely than paid providers to have other employment. While almost half of unlisted unpaid providers have other jobs (48 percent), less than a sixth of listed providers (13 percent) and slightly more than a quarter of unlisted paid providers (28 percent) have other paid employment (Exhibit 7).

HEALTH INSURANCE

Data were collected from home-based providers in 2012, prior to implementation of the Affordable Care Act. These data do not indicate the adequacy or affordability of health insurance, only that the provider had some form of coverage. In 2012, over a quarter of unlisted paid providers (28 percent) reported no health insurance of any type. This was true of one in five listed (20 percent) and about the same proportion of unlisted unpaid providers (19 percent). Private health insurance provided by an employer or workplace is the most prevalent type of insurance coverage for listed (38 percent) and unlisted unpaid (35 percent). Among unlisted unpaid, the most common types of coverage are private health insurance provided by an employer (27 percent) and public insurance such as Medicaid, Medicare, military health care or other public programs (23 percent). More than a tenth (13 percent) of listed providers participated in a private health insurance plan purchased directly whereas small numbers of unlisted providers did so (Exhibit 8).

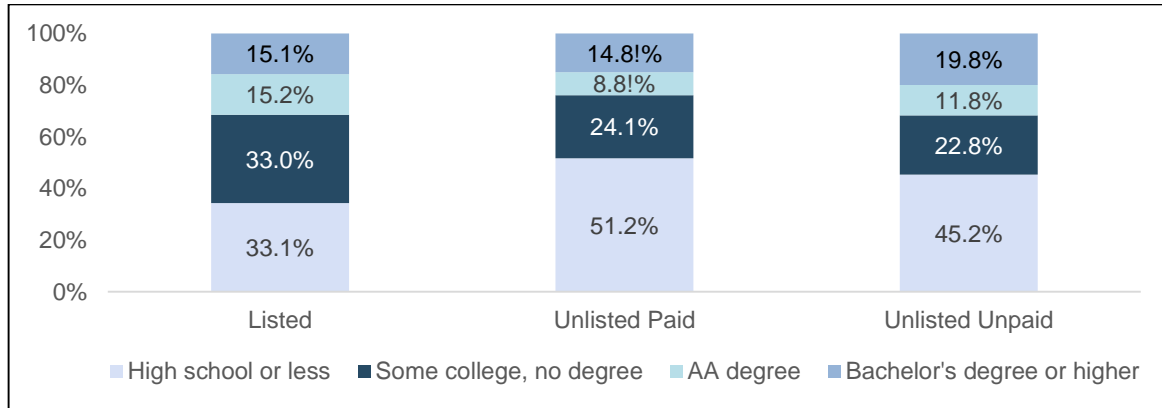

EDUCATION

Listed providers are the most likely to have some college or higher levels of education (63 percent vs. 48 percent of unlisted paid and 54 percent of unlisted unpaid). Unlisted unpaid providers are more likely than unlisted paid providers to have a bachelor's degree or higher (20 percent of unlisted unpaid vs. 15 percent of unlisted paid) (Exhibit 9). Non-prior-relationship providers with some college or higher were asked their postsecondary education (PSE) major. Over a third of listed providers (34 percent) have an Early Childhood Education (ECE) or ECE-related major while less than a tenth of unlisted paid providers (7 percent) do (Exhibit 10). Information on prevalence of ECE certificates can be found in a NSECE Project Team report focused on measuring predictors of quality in ECE.⁵

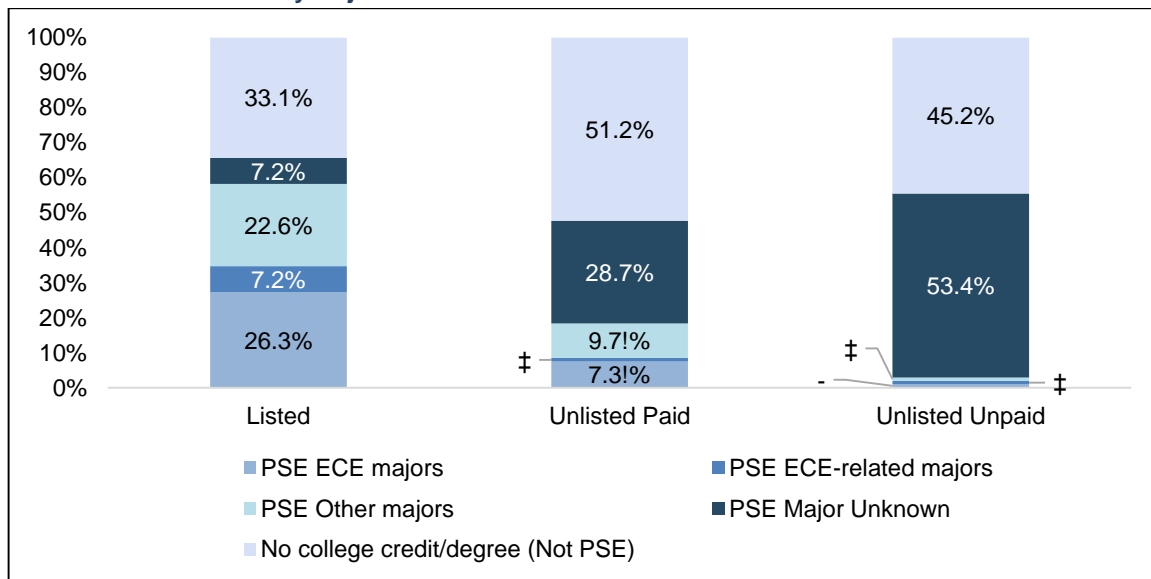
Exhibit 9. Highest Educational Level Attained by Home-based Providers

RECENT TRAINING AND OTHER PROFESSIONAL DEVELOPMENT

Participation in ECE training is more common for listed home-based providers than for unlisted paid providers (Exhibit 11). Three quarters of listed providers (75 percent) had participated in a workshop in the last 12 months while less than a quarter of unlisted paid (23 percent) had done so. Of the listed providers who participated in a workshop, a third reported participating in a series. Up to a third of home-based providers take college classes or are coached. Listed

providers are more likely to do so than are unlisted paid providers (30 percent vs. 12 percent taking a college course and 34 percent vs. 12 percent receiving coaching).⁶

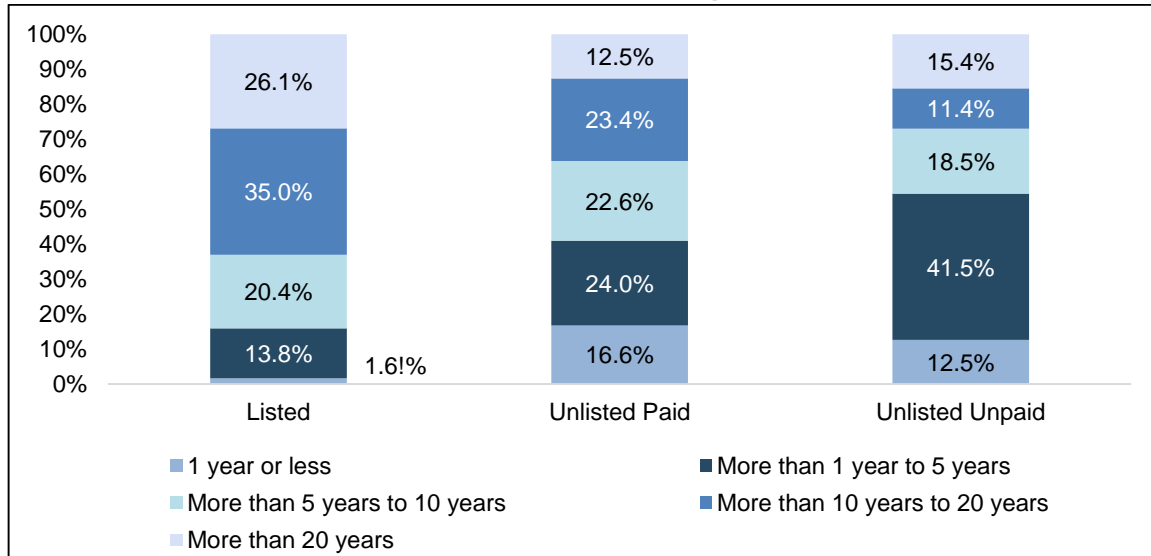

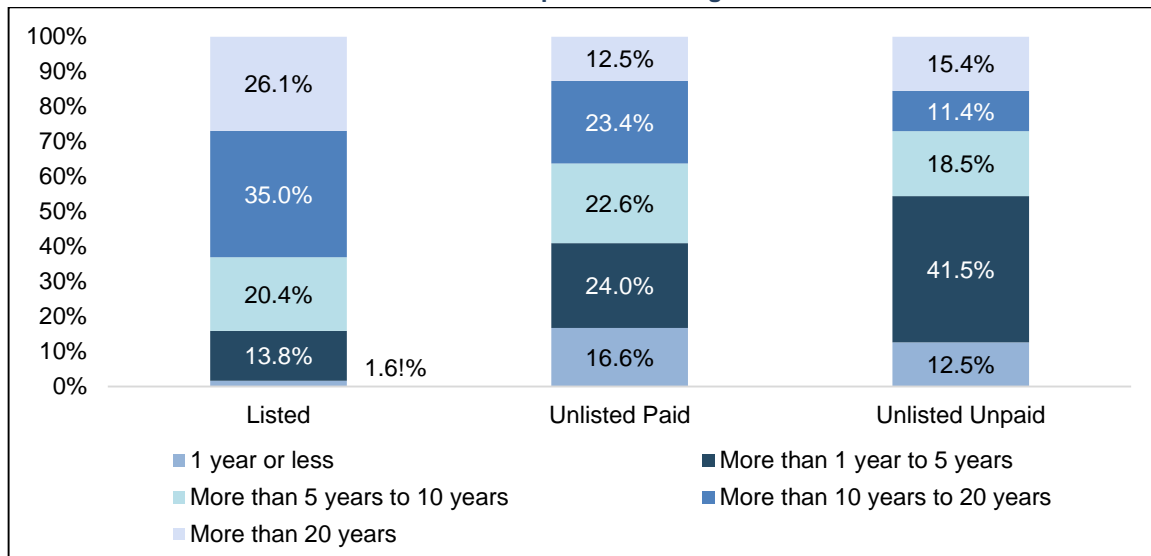
EXPERIENCE CARING FOR CHILDREN

Listed providers have substantially more experience caring for children other than their own than do unlisted providers (61 percent of listed have more than 10 years of experience vs. 36 percent of unlisted paid and 27 percent of unlisted unpaid). In fact, over half of unlisted unpaid providers (54 percent) have provided care to children other than their own for five years or less

whereas that is the case for less than one-fifth of listed providers (15 percent) and less than half of unlisted paid providers (41 percent) (Exhibit 12).

Home-based providers who care for at least one child with whom they did not have a prior relationship (non-prior-relationship-based) were asked if they had ever worked in an organization serving children under age 13 (e.g., a center or school). Listed providers are far more likely to have experience working in a center or school (35 percent) than are unlisted paid providers (17 percent). Individuals who cared only for children with whom they had prior personal relationships did not report their experiences providing center-based ECE (Exhibit 13).

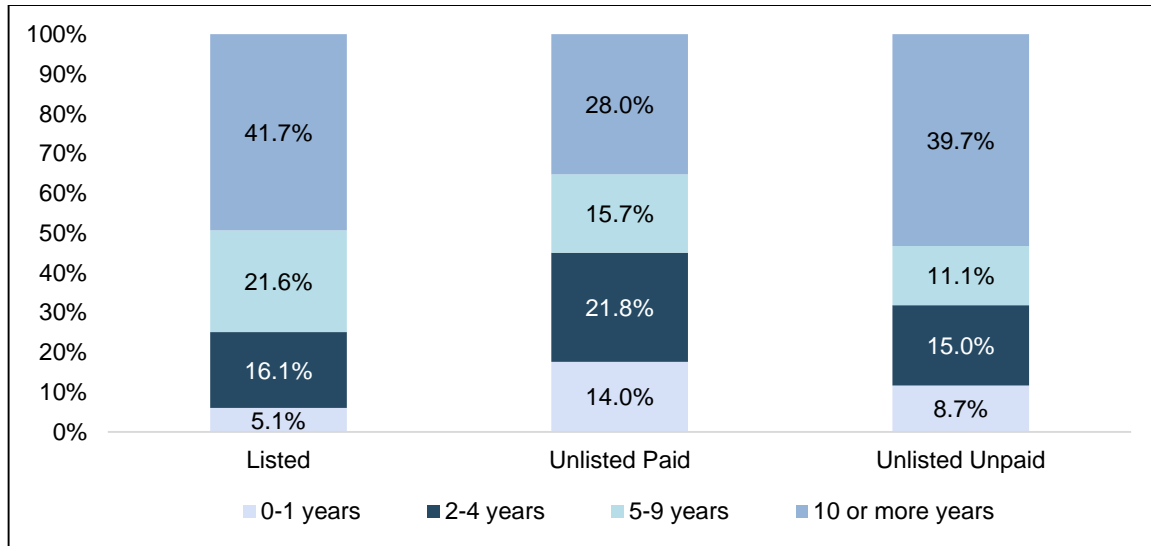

YEARS EXPECT TO CARE FOR CHILDREN

A substantial portion of listed and unlisted unpaid home-based providers intend to continue serving at least one child for 10 or more years (42 percent of listed and 40 percent of unlisted unpaid). Unlisted paid are more likely than listed to plan on doing this work for a year or less (14 percent of unlisted paid vs 5 percent of listed) (Exhibit 14).

MOTIVATION AND PERCEIVED RESPONSIBILITY

Career motivation. Exhibit 15 shows that different types of home-based providers tended to report different primary reasons for working with children. Almost half of listed home-based providers (47 percent) report a personal career or calling as their primary reason for looking after children; only small percentages of unlisted providers perceive this work as a calling or career (18 percent of unlisted paid and 9 percent of unlisted unpaid providers). Over three-quarters (77 percent) of unlisted unpaid home-based providers report helping children’s parents as their primary reason for looking after children. Helping parents is the primary reason for a smaller percentage of unlisted paid providers (45 percent) and an even smaller percentage of listed providers (8 percent). Fewer unlisted providers report helping children as their primary reason compared to helping their parents (11 percent of unlisted unpaid providers, 15 percent of unlisted paid). Earning money is seldom given as a primary reason for looking after children (8 percent of listed and 12 percent of unlisted paid).

Perceived Responsibility. Home-based providers commonly report one of three main responsibilities when looking after children: a) safety, b) nurturance and love, and c) helping development/providing for basic needs. Prevalence of these responsibilities varies between listed and unlisted providers. Listed providers most often reported providing for children's basic needs or keeping them safe similarly (30 percent for basic needs, 27 percent for safety) with a much smaller percentage reporting providing nurturing and love as their main responsibility (15 percent). Both paid and unpaid unlisted providers most often report their main responsibility as keeping children safe (60 percent of paid and 53 percent of unpaid). Unlisted unpaid are more likely than listed providers to report providing nurturing and love as their main responsibility (25 percent of unlisted unpaid vs. 15 percent of listed) (Exhibit 16).

CHARACTERISTICS OF CARE PROVIDED IN HOME-BASED ECE

As noted above, we began this report on home-based ECE with a description of the persons who provide the care. In the following section we describe the services they provide.

NUMBER OF PROVIDERS AND CHILDREN

Almost 4 million home-based providers cared for over 7 million children birth through age five, not yet in kindergarten in 2012. Unlisted unpaid providers are the largest group of home-based providers (2.7 million) with unlisted paid the next largest (919,000). Listed providers make up the smallest group (118,000) and serve the smallest number of children (Exhibit 17).

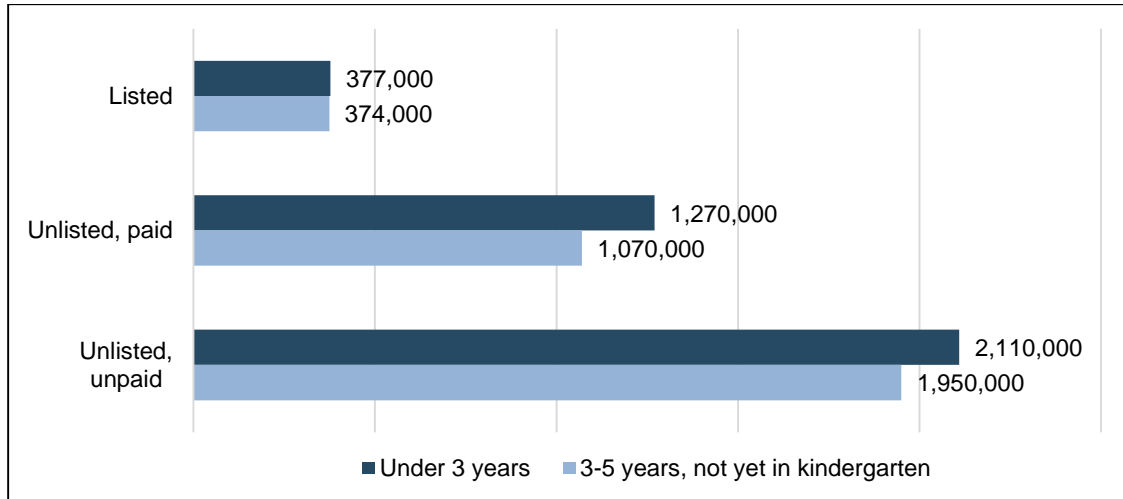

Exhibit 18 shows that home-based providers care for approximately equal numbers of infants and toddlers (under 3 years) as preschoolers (3 through 5 years). Although unlisted providers may appear more likely to care for infants and toddlers than for preschoolers, these differences are not statistically significant. Many home-based providers care for school-age children in addition to children birth through age five, not yet in kindergarten. Tabulations about home-based providers serving school-age children (whether or not they also serve young children) are included in the Appendix Tables.

The median number of children birth to age 13 cared for over a week is three times or more for listed providers as for unlisted providers (6.9 per listed, 2.3 per unlisted paid, and 1.2 per unlisted unpaid provider) (Exhibit 19). Exhibit 20 shows that when the count includes only those children for whom the provider receives payment, the pattern remains similar, with the median listed provider serving four times as many children as the median unlisted paid provider (6.5 per listed and 1.6 per unlisted paid). These weekly numbers may not represent the number of children present at any given time depending on the care schedules of different children.

PRIOR PERSONAL RELATIONSHIPS

Discussions of home-based care often refer to care provided by family, friends, and neighbors. NSECE data can describe each person who provides regular home-based care based on whether or not that person has a prior personal relationship with the children he or she cares for. Prior personal relationships could include family, friends, and neighbors, as well as colleagues, acquaintances from church, or other social ties. Providers caring for at least one child without a prior personal relationship are designated as ‘non-prior-relationship-based’, while ‘prior-relationship-based’ providers care only for children with whom they had prior personal relationships. Exhibit 21 shows the percentages of those who care for at least one child with whom the provider has no prior relationship. Overall, 91 percent of listed providers care for at least one child with whom they have no prior personal relationship. This drops to 35 percent among unlisted paid providers. Not surprisingly, individuals providing only unpaid care virtually always have a prior personal relationship to the children they look after.

Viewing the prevalence of prior relationships from the child’s perspective confirms that prior-relationship-based care describes the vast majority of home-based care. Although only 25 percent of all children served by listed providers have prior relationships with the provider, 74 percent of children in settings with unlisted paid providers and 98percent of children in settings with unlisted unpaid providers do (Exhibit 22). Note that these percentages are based on all children cared for in these settings, including school-agers.

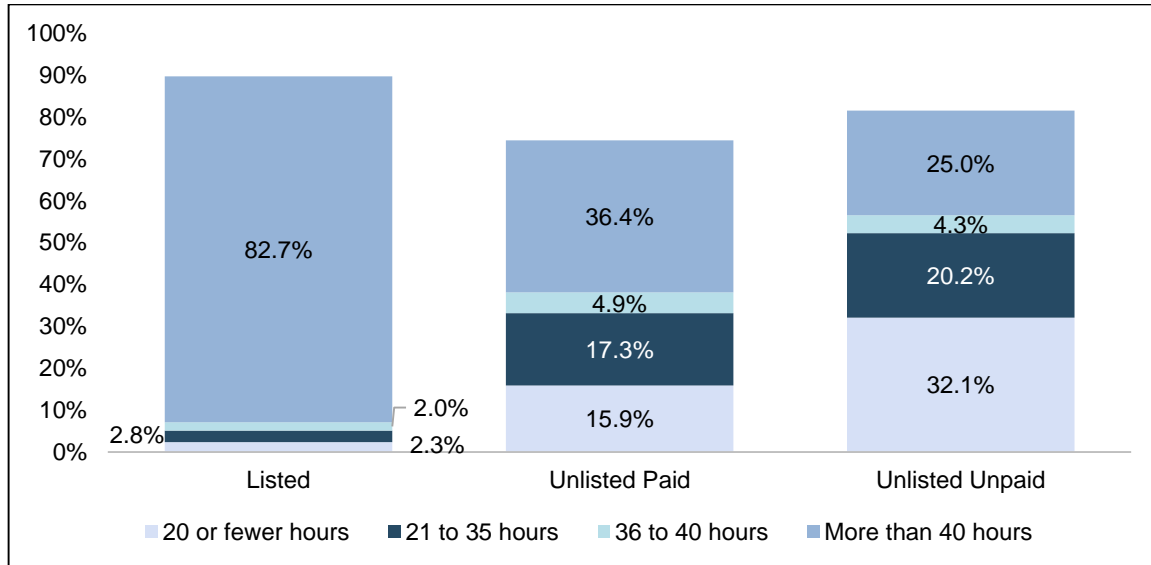

HOURS RELATED TO CHILD CARE

Hours directly providing care. Listed home-based providers are far more likely to provide care for more than 40 hours in the week prior to the interview than are unlisted providers (83 percent for listed vs. 36 percent for unlisted paid and 25 percent for unlisted unpaid) (Exhibit 23). Half of

listed providers care for children 54 hours or more each week compared with medians of 40 hours for unlisted paid and 24 hours for unlisted unpaid) (Exhibit 24). Two points stand out: a) even unpaid providers dedicate substantial hours per week to caregiving and b) there is substantial variation in number of hours of care given by unlisted home-based providers but not by listed providers (lowest quartile of listed give 50 hours or less while the highest quartile give 60 or more; the lowest quartile of unlisted paid providers give 22 hours or less while the highest quartile give 52 hours or more; and the lowest quartile of unlisted unpaid provide 13 hours or less while the highest quartile provide 46 hours or more). These numbers represent all hours in which any child is in care and not the hours that any given child is present.

Hours in addition to direct care. Providing child care requires time in addition to those hours spent in direct care. Caring for at least one child with whom the provider does not have a prior relationship indicates that the person is caring for community children. Those who provide care to at least one child with whom they do not have a prior relationship were asked to report time spent on activities such as planning, preparation, and record keeping. Half of listed providers spend more than 10 hours per week in addition to hours spent in direct care whereas half of unlisted paid providers spend more than 4 hours or more per week in these activities (Exhibit 25).

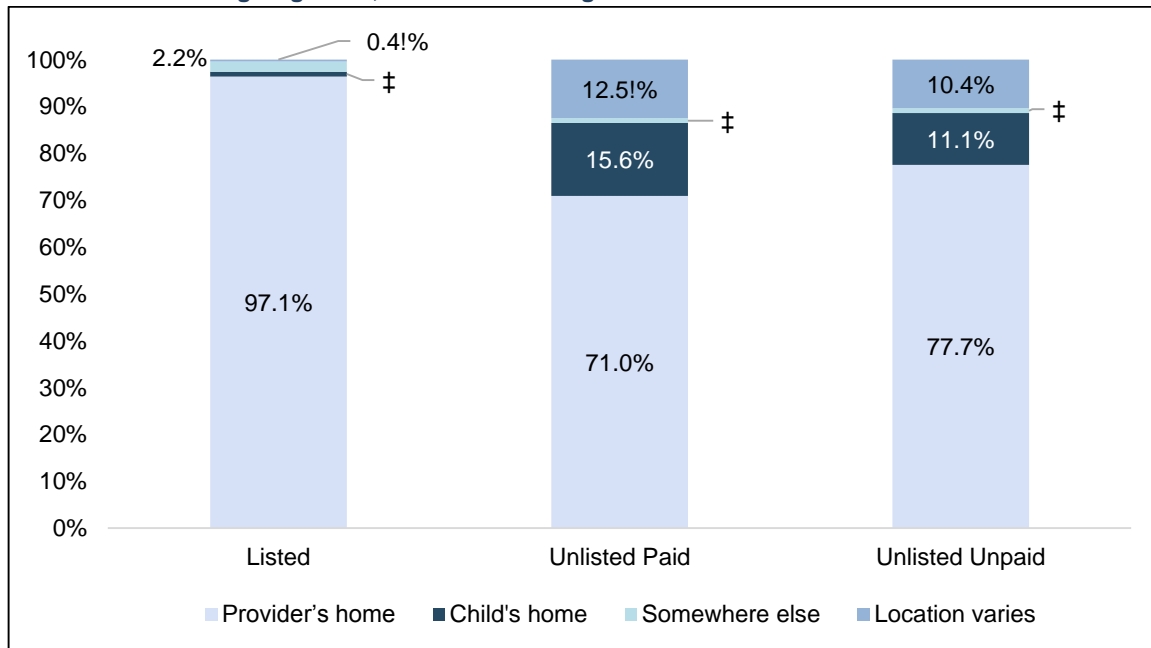

LOCATION

Virtually all home-based providers care for children in either the home of the provider or home of the child, although the provider’s own home is the most common. Almost all listed providers report providing care in their own home (97 percent). Smaller percentages of unlisted providers give care in their own home (71 percent unlisted paid and 78 percent unlisted unpaid). Unlisted providers report giving care in the child’s home or varying the location (16 percent unlisted paid and 11 percent unlisted unpaid providers give care in the child’s home while 13 percent unlisted paid and 10 percent unlisted unpaid vary the location). It is likely that providers who vary location move between their own and the child’s home as it is rare for a provider to report providing care in any other location (2 percent of listed and less than a percent of unlisted provides give care in another location) (Exhibit 26).

REVENUE FROM CHILD CARE

Weekly child care revenue. Listed and unlisted paid providers reported 2011 weekly revenue. Listed home-based providers report substantially greater weekly revenue from ECE than do unlisted paid providers (half report \$440 or more per week vs. \$56 or more per week reported by unlisted paid). The amount of revenue earned varies substantially for both listed and unlisted paid providers. Although half of listed providers report weekly income of \$440 or less, the top quarter earn \$769 or more. Among unlisted paid providers, half report child care revenue of \$56 per week or less while the top quarter report earning \$180 or more (Exhibit 27). Yet, listed and unlisted paid providers report similar maximum hourly prices. In a related report,⁷ the NSECE Project Team reported hourly prices charged by listed and unlisted paid providers. Median unsubsidized hourly prices charged by listed providers are between \$3 and \$3.20 per hour depending on age of child, while median prices for unlisted paid providers range between \$3.40 and \$3.80 depending on age of child. The substantial difference in revenue despite similarity in hourly prices appears to be due to the much smaller number of paid children served (median of 6.5 for listed vs. 1.6 for unlisted paid as shown in Exhibit 20). It may also be that for unlisted paid providers, children whose care is paid attend for fewer hours.

Annual child care revenue. Listed and unlisted paid reported 2011 annual ECE revenues. The same pattern of large differences in revenue between and within types of home-based providers is confirmed by findings on annual income from child care (Exhibit 28). Average annual revenues are higher for listed providers, and within both listed and unlisted paid providers some earn substantially more than others. Half of listed providers earn \$22,978 or less while the top quarter earn \$39,964 or more. Half of unlisted paid providers earn \$3,889 or less and the top quarter earn \$9,559 or more. These figures may not be representative of all child care providers' revenues in 2011, since 2011 providers no longer providing care in 2012 are not represented in the data.

ECE revenue sources: Among providers that receive income from ECE, payments from parents are the most common source (received by 84 percent of listed and 76 percent of unlisted paid providers) (Exhibit 29). Almost two-thirds of listed providers receive payments from governmental organizations (61 percent) while a far smaller percentage of unlisted paid do (14 percent). Other sources of income are uncommon although they make up a substantial percentage of income for those who receive them.⁸

PAID ASSISTANTS

Only non-prior-relationship providers were asked if they employed assistants from outside of the provider’s household. Although almost four in ten listed providers (39 percent) report having paid assistants, the practice is less common among unlisted paid providers (12 percent) (Exhibit 30).

Conclusion

The NSECE data shows that home-based care is not one phenomenon. Rather, those who provide home-based care to children fall into distinct groups characterized by both their own personal characteristics and those of the services they provide. Findings from the NSECE provide a consistent picture of both listed and unlisted unpaid home-based providers. This is not the case with unlisted paid providers. The data show variation in characteristics within each group. In addition to this variation, the unlisted paid provider group appears to be composed of subgroups. Below we provide a portrait of each type of provider: listed, then unlisted unpaid, and finally unlisted paid. Because we explore possible subgroups in the unlisted paid category, we are altering the order in this section relative to what has been standard elsewhere in this brief.

LISTED HOME-BASED PROVIDERS

Approximately 118,000 listed providers care for over 750,000 children ages birth through age five, not yet in kindergarten. The majority are middle aged (ages 30 to 60) and married or living with a partner (73 percent). Half have household incomes of \$45,000 or higher and the approximately half earn half or more of their income from child care (47 percent). The vast majority have health insurance (80 percent) and perhaps surprisingly over a third report the source of their insurance to be related to their employment (38 percent).

Most listed providers have attended college (63 percent), although they are not likely to have obtained a bachelor’s degree (15 percent). A third had postsecondary education majors in Early Childhood Education or a related field (34 percent) when studying in college. The vast majority participate in professional development with three-quarters having taken workshops in the last year (75 percent), almost a third taking a college course (30 percent), and a third having received coaching (34 percent). They also bring substantial amounts of experience to this work, with the majority having 10 years or more experience caring for children not their own (61 percent) and a third having prior experience working with children in a center or school (35 percent). A substantial portion intends to continue working with children for 10 years or more (42 percent).

Almost half consider their work with young children a personal calling or career (47 percent). They report as their primary responsibility: meeting children's basic needs (30 percent), keeping children safe (27 percent), providing nurturing or love (15 percent), and supporting development (5 percent).

Since these home-based providers were identified by their presence on a list within their state, it is not surprising that the vast majority (88 percent) meet a definition of family child care. All but nine percent care for at least one child with whom they did not have a relationship before the child entered care. Virtually all are paid for giving care (98 percent) and provide care in their own home (97 percent). Half serve seven or more children in a week. Also, half spend 54 hours or more a week directly providing care. In addition to direct care, providers spend time doing related work such as planning and preparing; half of listed providers spend 10 hours or more per week on these related non-direct care activities. A substantial group has paid assistants who are not part of the provider's household (39 percent).

Another indication that listed providers are operating businesses is the amount of revenue they generate from ECE. Half of listed providers report 2011 annual revenues from ECE of \$23,000 or more and 2011 ECE earnings of at least \$440 per week.

Data are not available on the revenue sources of all listed providers, but among the two-thirds who described their revenues, parents are a source of revenue for the vast majority of listed providers (84 percent), and parent fees make up the majority of their revenue for those who have this as a source (77 percent). More than half also receive funds from government sources (61 percent) and for these providers, public sources provide a significant portion of their income (41 percent).

UNLISTED UNPAID HOME-BASED PROVIDERS

Over 2.7 million unlisted unpaid providers care for over 4 million children ages birth through age five, not yet in kindergarten. Virtually all of these children are within the provider's existing social network as almost all have relationships with the children prior to giving care (97 percent). The majority of unlisted unpaid providers are 50 years of age or older (60 percent), including a third who are 60 or older (33 percent). A majority are currently married or living with a partner (58 percent) and an additional quarter have been partnered in the past (24 percent). Half had annual household incomes of \$40,000 or higher in 2011 (since they are unpaid, the income is not from ECE). Almost half (48 percent) have employment other than their unpaid ECE activities, which fits with the small number of children for whom they care. The vast majority have health insurance (81 percent). For a third of unlisted paid providers the health insurance is workplace related (35 percent), and almost a quarter have publicly provided insurance (21 percent), consistent with their age distribution.

Over half of unlisted unpaid providers have some college or higher (54 percent) with one in five having a bachelor's degree (20 percent). Perhaps surprisingly, many of these providers are making a long-term commitment to providing early care and education. Forty percent of them expect to provide care for at least another 10 years. Most are motivated by a desire to help children's parents (77 percent), in contrast to listed providers whose primary motivation centers on children. Providers most often report keeping children safe and out of trouble as their primary responsibility (53 percent), with 'providing nurturing and love' as the second most commonly reported primary responsibility (25 percent).

Unlisted unpaid providers are not providing services for the community at large. Virtually all have a personal relationship with the child prior to the child entering care. Almost one half of

these providers care for one child, while the average number of children in care across all unlisted unpaid providers is two. Still, they provide substantial hours of care. Half provide 24 hours or more of care per week with a weekly average of 34 hours; some are providing substantially more hours. Although their own home is the most common location for caregiving (78 percent), almost a quarter provide care either in the child's home (11 percent) or vary the location (10 percent), probably between their own and the child's home, as the percent using any other location is miniscule.

UNLISTED PAID HOME-BASED PROVIDERS

Almost a million (919,000) unlisted paid providers care for over 2.3 million children ages birth through age five. The data suggest that distinctive subgroups may exist within the group of unlisted paid providers. Portions of this group appear similar to listed providers, while others seem more like unlisted unpaid providers. For example, a full 65 percent provide care only for children with whom they have a prior relationship and thus are similar to the unlisted unpaid providers except that they get paid. About a quarter meet a basic definition of family child care (22 percent), but they are not on any state or national ECE lists. (Given that many states do not require a provider caring for a small number of children to be regulated, many in this group may not be required to be licensed in their state.) Another group (16 percent) provides care for pay in the child's home, a group not typically covered by licensing and thus unlikely to appear on an administrative list. When viewing the characteristics of unlisted paid providers it is helpful to keep in mind these within-group differences.

Unlisted paid home-based providers tend to be young, with about a fifth under 30 (21 percent) and four in ten under 40 (42 percent). Not only are they younger than listed and unlisted unpaid, they are more likely to have never married (23 percent) than the other groups of home-based providers (5 percent listed and 17 percent unlisted unpaid). They have substantially lower household incomes (half have incomes of \$25,000 or less compared to \$45,000 for listed and \$40,000 for unlisted unpaid). Whereas 41 percent of listed providers earn less than half of their income from ECE, 69 percent of unlisted paid earn less than half from these activities. Over a quarter have other employment (28 percent). Almost a third have no health insurance coverage (28 percent) and almost a quarter have publicly supported insurance (23 percent).

Unlisted paid home-based providers have relatively low levels of education. Half have a high school diploma or less (51 percent), and a small percent have a bachelor's degree or higher (15 percent). In terms of professional development, whereas three quarters of listed providers have attended one or more workshops in the last year, less than a quarter of unlisted paid have done so (23 percent). Small percentages have taken ECE college courses (12 percent) or received coaching (12 percent). Less than half (41 percent) have five years or less of experience caring for a child other than their own. Relatively few have work experience in a center or school (17 percent). This group of providers is the most likely to plan on doing this work for less than five more years (36 percent of unlisted paid vs. 21 percent of listed and 24 percent of unlisted unpaid). Almost half do this work to help children's parents (45 percent), and over half perceive keeping children safe as their primary responsibility (60 percent).

The majority of these providers are not providing care to the broader community as almost two-thirds (65 percent) care only for a child with whom they had a relationship before the child entered care. Half care for about two children each week with the average at four children across all unlisted paid providers. Half provide care for 40 hours or more a week, and among those caring for at least one child with whom they did not have a prior relationship, half spend an additional four hours or more a week doing work related to caregiving. They earn far less

from ECE than do listed providers (half earned \$56 or more a week in 2011 and \$3,889 per year in 2011 vs. \$440 per week and \$22,978 for listed providers). Parents are a source of revenue for 76 percent, who receive 91 percent of their income from that source. Fourteen percent receive revenue from government with 72 percent of their revenue from that source. Twelve percent have paid assistants who are not part of their households.

What seems likely is that unlisted paid is not a single group, but rather that this group of home-based providers includes at least three distinct subgroups. The first is made up of persons with prior connections to the families of all the children for whom they provide care but who receive some payment for their work. Caring only for children with whom they have prior relationship distinguishes this first group from a second group that includes persons who care for at least one child with whom they had no relationship prior to caregiving, but who do not appear on an administrative list, possibly because they care for small numbers of children. A third subgroup provides care in the child's home. Further research is needed to determine if subgroups exist and if so, how many and how they compare with one another and with listed and unlisted unpaid providers.

Appendix I: Detailed Tables
