

Public Comments relating to the National Advisory Committee on the Sex Trafficking of Children and Youth in the United States held on January 6, 2022

Dear National Advisory Committee on the Sex Trafficking of Children and Youth in the United States,

I was 15 years old, kidnapped against a No Contact Felony Warrant in the State of Florida. Taken under duress by a fugitive sitting overseas, and because the State Attorney's Office doesn't recognise me as a victim of my own abduction, refused to talk to me when I called from San Francisco in April 2004. Where the Human Trafficker was in a jail cell, refusing to give me money to survive. The Extradition Notice was for my abduction, not the 2nd kidnapping that wasn't reported and now no one helps even though I have the evidence.

The failure to recognise the minor children as victims, put me in an unthinkable position in 2004. As I had to just continue to rely on my abuser as the Police wouldn't talk to me or the State Attorneys office. In my own abduction and the perpetrator was caught at the border with me. I was an adult so was left to flounder.

How can this happen? How can I have been left to sink like that. Its appalling and a gross failure in the system to protect children. The active warrant is still open in the Ninth Judicial Circuit Court in Orlando, and the perpetrator is now using high paid attorneys to silence me from speaking up publicly. How can this happen in 2022?

I am upset with the system, because too much pain and suffering could have been avoided. Though complex trauma I know made the entire years of abuse confusing and scary. I was a boy, now a man but still a human being who has to have justice and the truth. Why does a child who grew trafficked and in captivity have to beg for help from the foreign shores he was taken too and ran away too/

We don't make progress by ignoring the problem, we have to work together to understand how the abusers/traffickers exploit the system to gain silence and leverage over children and adults trafficked.
