I'm a mom of 6. My oldest son is 21 and my youngest daughter is 9 months old. My children have been stolen based on false allegations that I fought and won but are still being denied their return. My 13 year old daughter is rebellious and doesn't want to do what she's supposed to. So even after successfully raising a now 2nd year college student who's studying Psychology at Medgar Evers College. Instead of looking at the facts our situation when dealing with agencies who have tried to or are helping, I was told that CPS went too far. I'm still fighting, but my history shows the type of mom I am to my children. My daughter now 13 hasn't attended school for the entire school year as of yet but when in my care was attending school and functioning like a normal teenager now in CPS care has AWOL everyday for 8 months. Anything could happen while she's in their care. That's how it starts. They break up families so young girls and boys can get taken advantage of. What a system. It works for them not the children

Dear Mr President

We need help immediately!

If you are not familiar with who [redacted] is, I will give you a brief background.

[redacted] is a 13 year old girl from Wilsonville, OR who was diagnosed with a cancerous tumor. She underwent 6 months of chemo therapy at OHSU. After months of declining health and no progress on the tumor, she was released to her mother's care. Her doctors basically released her to die.

[redacted]'s mother, [redacted], started her on a naturopathic regimen that included CBD oils. [redacted]'s health rapidly increased. When they went back in for a checkup, the tumor had actually shrunk. At that point the doctors wanted to proceed with a risky surgery to remove the tumor. [redacted] and [redacted] both wanted to continue with her naturopathic regimen rather than risk the surgery. At this point Child Protective Services got involved and wanted to take [redacted] away and force the surgery.

Fearing her child's safety, [redacted] ran away with [redacted]. FBI agents found and apprehended [redacted]. [redacted] now has a criminal charge of child endangerment.

For the past few months, [redacted] has been in foster care and has barely seen her mom. She is terrified and CPS is moving forward with the surgery. To make matters worse, [redacted] was molested by her foster mom's boyfriend earlier this week. [redacted] was taken out of that home and placed into another. [redacted] is terrified and wants her daughter back home.

WE NEED HELP GETTING [redacted] HOME TO HER FAMILY FOR CHRISTMAS. [redacted] has immediate family in the area but CPS will not even let them take her. There is corruption going on and this case needs to be exposed. PLEASE HELP!

I have gone through all the facts with [redacted] and have written them all below. I have [redacted]'s contact details.

It is Christmas Eve and [redacted] wants to be back home with her Mum. This is something that should never, ever have happened. Please, please Mr President, please help [redacted] get her daughter back. I have all her contact details.

[redacted]'s Fight

The unbelievable, but true story of [redacted], and her Mum, [redacted].

Background

I originally became aware of this case via a Facebook friend who shared a video of a young girl begging for her life and was absolutely horrified at the story. I still cannot believe what the family is having to go through on a daily basis.

What's been happening

[redacted] from Oregon, USA, was found to have a mass tumour inside her liver on 28th February 2018. She was given 3 full rounds of the strongest form of chemotherapy, one of them being Mustard Gas which was the reason why [redacted] fell into a coma and had neurotoxicity to the brain and almost died. Her mother, [redacted], spent a lot of time researching the type of cancer [redacted] had. When [redacted] came out of the coma, [redacted] wanted to take [redacted] away from the hospital. The doctors wouldn't allow this.

Just before the fourth round of chemo was due (6 months later), [redacted]'s lawyer sent the hospital a letter stating that the doctors were illegally holding them there, and they had to allow her to take [redacted] out of the hospital. This would give her some time to recover before the fourth round of chemo was administered, and with the doctors saying that [redacted] only had 4 weeks to live. They threatened to take back [redacted]'s already approved 'Make A Wish' vacation trip from [redacted] and [redacted], if they did not return by the given date for more chemotherapy. When they did not return, the doctor involved demanded the Make A Wish Foundation to remove [redacted] off the approved list to get her wish granted, as [redacted] was 'no longer medically fit' for the vacation previously approved! The doctor was one of the board of directors on the non-profit organisation, which seems rather ludicrous and is surely a conflict of interest when allowing this to happen!

While away, [redacted] began treating [redacted] with juicing, CBD oil and other natural forms of healing via a neuropath, and [redacted] became stronger day by day. [redacted], through her research, found that chemo was not safe for [redacted]'s type of cancer, and in fact, could cause her death. The doctors at OHSU witnessed that [redacted]'s tumour had, in fact, shrunk drastically by 80%. With this information, they called DHS/CPS and reported [redacted] for neglect because she refused to take [redacted] back for the fourth round of chemo. Why should she? She had turned [redacted]'s life around as [redacted] had started walking, talking and breathing on her own again. Because of the refusal, the CPS and the Family Court became involved and forced and threatened [redacted] to sign over her rights to her own daughter to them. She was told that if she didn't, they would see that she spent 20 years in prison and would never see [redacted] again. Out of fear [redacted] signed the papers.

[redacted] became very afraid and ran away leaving her Mum a note, saying that she did not want to have any more chemo or surgery and she was scared that her Mum would get into trouble. When [redacted] found her, they left the State of Oregon and went to a motel in Nevada. [redacted] was still improving day by day. Unfortunately, when they did not turn up at the hospital for the scheduled appointment, the police were informed and the FBI, State Police and the "A" force tracked them down. One FBI member told [redacted] that she should go straight back to Oregon and fight like hell for her daughter, as the situation was very wrong.

[redacted] was taken to a holding place which was obviously a place for juvenile delinquents and certainly not seriously ill children. Here [redacted] was threatened, abused and not given her medications which caused severe pain as she went into withdrawal.

[redacted] was jailed for 'custodial interference' and 'criminal mistreatment', which is ridiculous as her daughter had improved immensely under [redacted]'s care, along with the help of a neuropath. (Please note, that the first neuropath to treat [redacted] was found murdered.)

There are plenty of family members who [redacted] could have been placed with, but it's never been allowed. Instead she has been placed in foster care, with people she doesn't know and while she is sick! Her caseworker had even stipulated that there should be zero contact with any family members. Having one male caseworker solely responsible for [redacted], in itself is very strange, as [redacted] at her young age should have had a female caseworker.

Here are some brief but extremely important points about this story:

- The doctors at OHSU originally said there was no cancer, but then said the following week that there was, that it was very severe, and that [redacted] wouldn't make it.
- [redacted] went into a coma whilst having chemo.
- [redacted] was diagnosed with lung cancer as well as the liver cancer; however, after a course of antibiotics and refusal from [redacted] with regards to [redacted] having a lung operation, there was no evidence of lung cancer.

- Both [redacted] and her mother have been threatened by the District Attorney (more than once), the OHSU doctors and DHS/CPS. The doctors told [redacted] that they would drag her kicking and screaming into the operating theatre whether she liked it or not. They also told [redacted] that if she went to court, they would have CPS take [redacted] away from her.
- A judge overturned a scheduled liver operation on [redacted] as she said there was no evidence that it would do [redacted] any good.
- The same judge ruled that [redacted] had been forced to sign the document saying that she would bring [redacted] back for the 4th round of chemotherapy.
- [redacted] has often been denied the right to see/talk to [redacted]. When she has had phone calls they have been monitored and they are not allowed to discuss the case. [redacted] has also not been allowed to know where [redacted] is. She has recordings as proof. She was, however, allowed to see [redacted] briefly on 14th November before court. As you can see from [redacted]'s face in the photo attached, she loves her mother very much.

Court hearing: 15th November 2019

[redacted] reported that during the hearing it was obvious that her attorney was not standing up for her, for reasons unknown (but we can assume that he may well have been either threatened or paid off). He did not provide any witnesses that had been discussed in the previous weeks, and he denied seeing a list of people to subpoena. Questions must be asked here as to why he did not think to contact [redacted] to ask for a list, knowing how it was imperative that she have people on her side in court. She told the judge that she no longer wanted to use this lawyer and wanted time to get another, to which she was told that the hearing would proceed with [redacted] representing herself. This, of course, is unbelievable, as even murderers have rights to representation in court. The judge awarded the CPS custody of [redacted].

[redacted] has fought tirelessly to get her daughter back, as well as help other families who happen to be in the same situation as her, i.e. children being medically kidnapped, even though the parents have done nothing harmful to them at all.

As it stands today, [redacted]'s life is in extreme danger. It appears that those who say they have found an alternative cure for cancer, have a way of disappearing.

Another court hearing was due to be held on 16th December. The DHS postponed this until January. That same day, [redacted] was removed from school by the DHS and taken away from the foster home. [redacted] has been told that [redacted] was being abused while in foster care. How much more pain should this poor 13 year old girl have to endure? She has not been allowed to see her Mum for 9 days now. [redacted] has now been told that the DHS has booked CT scans for [redacted] and an operation as well - despite the fact that they do not have the correct medical team for the procedure.

Something needs to be done urgently to get [redacted] back home to her Mum, the only place she belongs.

My name is [redacted] and cps took my husband and i's 19month old son because I have anxiety and ptsd and panic disorder and because I'm on Xanax and Prozac they are claiming it makes me unfit to parent and my son has always been healthy and happy and loved and well taken care of and he wasn't ever sick or hurt in our care and our house is clean and spotless and no safety issues and since cps wrongfully took our son six weeks ago, cps hasn't allowed us to see our son and they are trying to terminate our rights illegally, please help, we love and miss our son and their other slander from cps of el dorado county is that because my husband is a chef and he works a lot and they claim our son's dad doesn't have a bond with our son which is a bold faced lie and cps never should have taken my son and there were no grounds to take him and now they are trying to terminate our rights illegally and cps needs to return our son and leave us alone because a mom having anxiety and ptsd isn't a reason to take a child and our son was always loved and healthy and happy and he wasn't ever hurt or sick in our care ever, please help us get our son back, and our son's name is [redacted] and he's 19months old and there wasn't a single legal reason for our son to be ripped away from loving parents and cps won't let us see him and we don't know where our son is or who he's with and we haven't committed any crimes and our son was well taken care of please help us get our son back, cps in placerville,ca illegally took my son [redacted], we miss and love him so much and he's our whole world

Child Sexual-Abuse/Possible Child Trafficking Attempt/Major Rights Violations (Erie County, NY)

To whom it may concern,

My name is [redacted] and I am writing you today in hopes of attaining relief for my daughter, [redacted]. We are facing extreme overreach and abuse at the hands of the Erie County, NY Family Courts.

My child was unlawfully removed from my custody, because of a Facebook post I had made, which I was well within my rights to make, as affirmed by *Packingham vs. North Carolina*, and other Supreme Court rulings. Since then, my daughter and I have been greatly bullied and harassed, and my daughter has been placed with her abusers, despite overwhelming evidence that she is being neglected, abused and sexually-abused. My daughter has told 7 people, including a social-worker that she is being abused, unprompted, since she was 3. However, prior to her turning 3, neglect and abuse was occurring, most of which I have documented. This has all been ignored and downplayed by the courts.

I am an educated man, of sound mind, who recently passed a court-ordered mental-health evaluation, showing no signs whatsoever of psychiatric illness. I have video-evidence, with witnesses present, that clearly shows my daughter tells us she is being hurt, "over and over and over" (in her words), at her mother's household. This is a household, that has a history of covering up sexual-abuse in the family (Look into why [redacted], the mother of my child's grandfather, is barred from going near our child).

Personally, I have been sexually discriminated against by our Child's Attorney, [redacted], a woman who associates with MANY nefarious characters (this is so well known it's written about in local publications), including former members of the child sex-trafficking cult, NXIVM. (Such as [redacted]). Her son, works for a foreign-nationalist group, funded by the same family that funded NXIVM... As an American parent, this is ALARMINGLY too close for comfort.

I have had a petition detailing instances of abuse and over 100 violations of our court ordered parenting agreement that has been sitting in the court for over 3 years. The first judge [redacted] kicked this down the road, even taking a vacation on a day we were scheduled for court to hear this petition. (The mother of my child was having an affair with [redacted]'s close family members at the time of our break-up, while pregnant with my child. She refused to recuse when requested by petition, saying, "Everyone knows everyone in Buffalo".

After this judge ignored my petition for over a year... again, a petition detailing abuse that was occurring to a child, on many occasions... and after my child looked me in my eye and reported to me for the SECOND time that year, that she had been sexually-molested in her mother's household, I reported this, as one would assume. However, I was IGNORED for over 14 days, with police refusing to take my report and CPS not returning my calls. ([redacted] of CPS confirmed this on the witness stand saying that the Erie County Sheriff's Office, "Told [him] to ignore [me]").) After being ignored, I went public, as it was the only other thing I could think of to get help for my daughter. I never made any threats of harm toward ANYONE. I have never posed a threat of imminent harm to ANYONE, especially my own child. I simply posted what I knew to be true about our case, in hopes that someone... anyone... would help us.

No one did... Instead, the case in it's entirety was handed over to [redacted], an activist judge with nefarious connections, as well. She bullied me for over 2 years in a "neglect" court. Her, [redacted], [redacted] and [redacted] conspired to unlawfully KIDNAP my child from me, because I was speaking out about their unethical and perhaps criminal behavior, regarding their handling of our case. They did this in direct violation of the Supreme Court's ruling in *Packingham vs. North Carolina*, circumventing our nation's laws. And they did this in direct violation of Title 18 Sections 241 & 242, of the laws of our Constitution. (Deprivation of rights under color of law & Conspiracy against rights).

I would later learn that [redacted], of the FBI and recent public infamy, presented the Judge in our case with "FBI Honors" for "Community Leadership", along with a couple appearances on Oprah. This turned my stomach. I am no attorney, but my understanding of [redacted]'s character is that he has no character, and is a traitor to this nation, who conspired against our president. And I have personally witnessed [redacted] operate and do not find her to be honorable, let alone competent enough to be sitting behind the bench. It's just a hunch, but I feel [redacted] and the talk-show host are involved in "propping up" people involved in these criminal-rings, to make them seem less suspicious. Just read the transcripts from our kangaroo court proceedings... The shoe fits. But, I'll let you guys decide on that one.

Given the seemingly unending discrimination and abuse my daughter and I are experiencing, the various agencies that seem to be involved in covering this up, and the fact that nothing seems to be being done to help us, has SEVERELY damaged my perception of the judiciary, and legal-system at large. I'm sorry, but we have simply been wronged. And we're still being wronged. At the hands of the very people who are supposed to be helping us... This alone, is upsetting enough. Coupled with waking up every day and knowing my child is in danger and no one cares to hold her abusers accountable, my patience, fortitude and restraint is being tested to it's very limits.

We needed your help, YEARS AGO. However, I didn't even know this organization existed until today. I stumbled across this article:

The article says you will help us... Is it true? I really hope so.

We have been let down so many times... I just want this all to be over. Please help my little girl. Please, I'm begging you, as father who expended everything he has and has been fighting on "fumes" for the last year. I am a good man. A good American. Who is a good community member, as well. My daughter is a very intelligent, well-spoken and discerning child. She does not lie to her father. And I believe what she has told me.

Please... Believe us. We are telling the truth.

I could go on and on... There is so much more. They are currently trying to throw me in jail for 60 days for posting on Facebook about what they are doing. The county attorney doing this, now 3 times in the last month, is

[redacted], who has been publicly reprimanded by The Buffalo News for trying to issue "gag orders" on law-abiding citizens against the law, previously. So, she knows what she is doing is wrong too.

There's just so much involved in all this. Please go to my Facebook page, "[redacted]". I have posted A LOT of evidence and explanation of what is going on out here, over the last week or so. I feel like I'm ranting here, and I don't want to overwhelm you and scare you off... (This seems to be common).

Look, I get it. This is a big problem, with scary people involved. And I get that no one wants to end up "suicided" or have their career destroyed for tangling with these folks. But you guys... someone has to help this little girl. I can't do it alone. I feel like I'm fighting alone out here, and it's terrifying. Please... If you can something, please help us.

Sex Trafficking Victims and Foster Care

I would love the opportunity to speak with the Committee. My daughter was missing for 16 months. She fell victim to sex trafficking and was further victimized by the human resource administration here in NYC.

Once recovered, by the grace of God, it was discovered that her choice was to live in a cage in someone's garage or be sold to some 50 year old man in New Paltz NY.

When she was retrieved Child Services got involved due to allegations that both capturer and victim had staged.

Child Services, does not follow the manual procedures that have been put in place. Not only that, the facilities that they place these children, they do not report when they are missing. My daughter disappeared 3 times while they were supposedly monitoring her. Girls and boys sit and recruit girls to be sex trafficked.

I would like a contract with the Government to monitor these holding facilities for compliance of their regulations. To speak with victims and help them recover. Perhaps with Recovery Coaches since most get exposed to drugs.

The traffickers have a pool of children at their disposal to be even further victimized and offer hope to the hopeless where they feel there is none. I can submit my proposal to service all 50 States.

I would like to share my story I'm detail so that it can be accurately depicted. A parents worst nightmare that gets exploited for. Dollar. Our children are not for sale.

Human trafficking by CPS

A county social worker (whom I requested assistance from in leaving my ex and finding safety for my 4-year-old and myself) and a city police investigator conspired with my abusive ex and falsified court documents to emergently remove my daughter from my custody, even though at the time she was in the care of her father. This occurred 1 year ago, 3 days after I attempted to leave him because I caught him naked and masterbating in our daughter's presence. I was put under surveillance while at a housing assistance appointment, and then pulled over

and drugs were found in my vehicle. I believe my ex was afraid he would go back to prison because he has a prior for 1st degree sexual assault of a 6-year-old, and he worked with this city and county worker to set me up. Their justification to the judge for removing my daughter was that I was being arrested and unable to provide care for her. But she wasn't in my care, she was with her father. I have requested police records and have proof that he was meeting these workers in secret prior to this event, all the while they were telling me they were there to help me and he was sweet talking me into 'working to fix our family'. There was a 48-hour hearing, which I was not notified of. When I wrote a letter to the judge a week later stating this and asking him to please reschedule the hearing, he recused himself and transferred me to a judge who was out of the office for two weeks. They had a fact-finding hearing where no facts were presented and everyone testified that I was an excellent mother and that my daughter was well taken care of. The judge ruled that he thought it 'miraculous' that the child had not been injured in my care and that he would ensure that she was not harmed in the future...by placing her with her abusive father who spent 5 years in prison for child molestation and admitted on the stand to bringing meth into our home and pushing it on me.

When this happened I was forced out of our home and onto the street, with no where to stay because he had been so controlling I had lost all outside friendships. I tried to go back in the winter to get warm clothes after the judge ruled he must let me get belongings, and he had me arrested, saying I was attempting to see our daughter outside of the court order. Now a year later, the ChIPS order has just been closed, but the Reunification they promised me was discarded because 'she was placed with a parent'. I can not regain custody because the only home I can afford is a boarding house room that doesn't allow children. I no longer qualify for the assistance I had previously lined up because I no longer have a dependent.

I want to press charges. I am sick of feeling scared, vulnerable and helpless. But I am afraid. Who do I even go to when both city and county are involved. I've already experienced retaliation for my DHS internal complaint, which went to the state level with no accountability. I have an attorney now who I am paying half my income to. He says he cannot move forward until I obtain housing.

I want something to be done. Everyone has continued to tell me to be patient it takes time, but all being patient has gotten me is a closed ChIPS order and an assumption that I actually neglected my child. Now I feel every day that I am court ordered to neglect her by leaving her in that environment I know to be harmful.

How do I press charges? And who against? I refuse to be a part of the problem when this happens again to another abuse victim.

We the people of Cortland county ask your help to remove judge [redacted] from the bench and investigate and shut down the child protective services department in Cortland county New York. this judge is taking children from good parents and placing them foster parents and a lot of them are getting molested our children need your help

To whom it may concern,

I have a few suggestions for ending sex trafficking in the foster care system.

#1. The first is that parents and children should rarely be separated. CPS does this because they are concerned with further harm of children, parents running away with their children, and being sued for inaction. This is simply false. If parents continue to have custody of their children they are more motivated to comply with CPS and keep their children with them. Currently it is emotionally devastating and traumatizing for both parents and children to be separated. If parents have an agreement in place to keep their children they are then less likely to run away with their children, if they know that they can work towards ending their open case with CPS. As it currently stands, CPS is not liable for any actions or inaction. Law suits are rare and typically because of constitutional violations and neglect due to an inability to keep track of the numerous cases on CPS behalf. Parents have a built in biological system to protect their children and keep track of their whereabouts.

#2. Expand the time for parents to be reunited with their children. The current model of 14 consecutive months of noncompliance is unethical, inhumane and needs to end. Other countries such as Australia have extended this time to allow parents to finish drug treatment and follow their case plans to be reunited. When parents have their parental rights terminated it leaves the state completely responsible for the welfare and safety of foster children. Many of whom would like nothing more than to be returned. CPS has a history of not being able to care for thousands of children and know their exact whereabouts. This is exactly how they become trafficked.

With parents unaware of the disappearance of their children they are unable to aid in the search for them. Social workers simply check a box indicating that they have run away.

#3. Offer real social services. Before children are removed from their homes offer financial help towards social services such as rent, daycare, and drug treatment. Parents aren't offered social services until their children are back in their custody.

#4. Allow teens 12 and older to make a choice to live with one or both of their parents. If children can make medical choices in certain states and the choice to be emancipated they should also be given the choice to live with their biological parents. Teenagers are more than capable of handling adverse situations. History and testimony of many great leaders has shown us that a little adversity is something to be overcome. If you gave teenagers the option of foster care versus living with their parents most would choose their parents.

#5. Allow parents to have their cases dismissed at their first 72 hour hearing. I had my CPS case dismissed within 3 months at the first trial. Parents should be allowed to show evidence at the first hearing which is allowed by law. Judges are used to going with the motions and stamping every case as a case to move forward with. Parents who can prove that their initial call was fraudulent should be allowed to have their case dismissed. Recently [redacted] called CPS on new parents in the hospital for not immunizing their child. Which was legal in the state of Illinois. The couple, as well as others in IL, had to go through months of investigation by CPS.

#6. Reduce funding for CPS. Social workers and investigators have a high turn over rate. The ones who stay are motivated by their incomes. These are the corrupt people that know how to keep cases open, and bring revenue to their department. The money needs to be redirected from foster care to biological parents. Foster parents who abuse and neglect children are also interested in the money they receive for having multiple children. By removing foster parents you reduce the risk of sex trafficking.

#7. Create a program for guiding parents. There is nothing social workers hate more than holding the hands of parents and walking them through the process of reunification. Yes, parents are typically adults. This doesn't mean that they are educated enough to go through a CPS case. Children have a CASA program, a guardian ad litem. A program specifically designed to assist parents in the court process, the CPS process, reading court material, helping parents walk into the court room, counseling parents, and other basic needs during this traumatizing time would benefit children. I met a young man who asked me where the court room for family court was. He proceeded to the court room, but instead sat down at a bench outside the doors because he didn't have the strength to walk through the doors. Assisting parents to regain custody of their children is the more basic and humane thing that society can do to allow the reunification process.

CPS has shown that they cannot take care of thousands of children. Nor can they find homes for them. The community has also voiced it's opinion in that they are unwilling to become foster parents and let this chaos continue. The corruption that CPS workers use to keep cases open is repulsive. If CPS has to lie in order to build cases they must not have a case in the first place. CPS is giving children to strangers to be abused worse than the initial reports. Background checks are simply no comparison to biological parents who have their children's best interest in mind.

Thank you for hearing my comments and for trying to reform the foster care system.

Dear Office on Trafficking In Persons,

Until your office determines to be “serious” about stopping the trafficking of children in Arizona and the United States, nothing will ever change for the better.

I have fought for children and families since I graduated in 1975; 44 years. I have worked in or with every single system in Arizona as well as the United States and even in Canada where I was given praise by the Canadian government for my advocacy for children and families.

The Arizona Department of Child Safety (formerly Child Protective Services) is guilty of either complete “incompetency” or “conspiracy” in trafficking children for a multitude of purposes:

This document is intended to share my 44+ years of experience advocating for children and families here in Arizona and around the United States. The list above demonstrates exact situations I have witnessed over my career.

1. Child Abuse: There are children that have been abused in Arizona. There are situations where children should be removed from their homes. The current environment allows for these situations. The issue here is that the majority of children that are taken/removed have no legitimate reason to be removed.

2. Medical Research: There seems to be an effort to identify children with genetic abnormalities, multiple births, rare diseases or conditions and those with Autism (Gov. Doug Ducey’s focus). (TGEN)

3. Pharmaceutical Trials: Some children in the custody of the state of Arizona have been given “black label” drugs according to parents I have worked with over the years.

4. State Economy: The state economy benefits from taking children in excess of billions dollars per year. Grants, Federal Funds, and employment.

5. Federal Funding: The state of Arizona draws down a variety of federal funds; Medicaid, Title VI-B.
6. Custody Battles: Parents and family members unwittingly use Child Protective Services to position themselves better during custody battles. They have no idea that many children are abused in state custody and on foster care. If they knew what could happen to their child they would not use the system at all.
7. Medical Malpractice: When a medical malpractice event occurs to a child an immediate call to "Risk Management" is made and a series of consistent steps/procedures are implemented. These steps or procedures are designed to implicate the Mother and a false accusation of "Munchausen Syndrome by Proxy" or "in the best interest of the child's treatment or recovery" is made by the hospital or medical entity.
8. Physician Error: The single physician error mirrors the steps/procedures used by the hospitals and their liability insurance risk management team assists in defusing the situation.
9. Medicaid: A separate funding stream from Medicaid allows physicians and hospitals to draw down for medical treatment. I have seen billings in the millions of dollars a year for one child. I have seen billings for services never provided and I have seen medical records for procedures that were never billed.
10. Adoption Pool: There are parents and foster parents that seek specific children they identify to adopt even before the child is removed from their family. Case Managers work to collaborate with these parents to have the children removed and parental rights severed. I have personally seen "severance plans" completed before the "case plan" or "reunification plan" has been written and implemented.
11. Social Engineering: Colleges and Universities teach prospective case managers and social workers to not worry about race, culture, sexuality, heritage, family surname, and to reengineer the child with a new name, new social security number, new culture, and erase past bonds of all family members. A complete disregard for the child's former self and family.
12. Employment: The number of individuals involved with a single child and family is an employment bonanza for Arizona's economy.

The quantity of individuals involved increases based on the case liability and the ability of the Parent/Family capability and financial resources. Most parents run out of funding quickly while the state of Arizona has bottomless financial resources.

Closing Statement:

After 44 years of watching Child Protective Services and Arizona's Foster Care system I would not wish these entities on anyone; not the worst enemy in my life would I want their children or them to fall into these horrific entities.

The atrocities to children in state custody are unspeakable.

Public Comments on Human Trafficking

- In 1995 myself and my five siblings were removed from our parents due to neglect in Ann Arbor Michigan Washtenaw County.
- Of note; my mother had attempted to be approved for food stamps, mental health services, and child care assistance multiple times and was rejected for being a nominal amount over the income level at the time. When I say nominal I mean \$100 or less a month over the income.
- My mother at the time had just completed CNA classes and was attempting to enter the work force for the first time and could not do so because she could not afford childcare.
- My mother at the time was suffering from Post Partum Depression and was denied mental health services.
- My mother was struggling to purchase food and to pay utilities and rent and was denied all forms of public assistance at the time.
- At the time of removal one child was over 18 and was not subject to foster care.
- At the time of removal five younger children were left alone overnight unsupervised by my mother for reasons unclear.
- At the time of removal the youngest child aged 5 years left the house looking for his mother and was found to be at a neighborhood grocery store late at night.
- At the time of removal the five youngest were assessed at an Emergency Room for child abuse and neglect and were placed in foster care.
- At the time of removal one child was 16 years old and missing. That child had snuck out of her home without the mother's knowledge.
- The Department was unaware the 16 year old child was missing for a period of six months until a younger sibling mentioned her.
- The Department attempted to place the 16 year old with her maternal grandmother who was physically and emotionally abusive to the child. The child ran away from that home. The Department never once contacted her or assessed her safety in her maternal grandmother's home.
- The Department then put a 'warrant' out for the 16 year old child as if she was a criminal and she was arrested and placed in Juvenile Detention until accessing a program intended for Independent Living.
- The Independent Living Program paid the 16 year old child's monthly rent and utilities at a rate of \$450 a month. They provided her a \$300 clothing voucher once.
- For a period of a year; the 16 year old was in the Independent Living Program and only met with her Case Manager perhaps four times.
- The 16 year old was offered no other services. No trauma services. No counseling. No visitation with her siblings. No contact other than the four times in person with her Case Manager.
- The 16 year old was accosted by a man that offered her a 'job' in California. The man paid for her Greyhound ticket to San Francisco, California.
- Upon arrival in San Francisco, California the man met the 16 year old at the local Greyhound Station and offered her a large sum of cash to meet a friend who had the job.
- The 16 year old took the cash and was led to a home in the Haight district of San Francisco.
- At that home she was accosted by a man that stated that she would have to 'work' for him if she wanted to keep the large sum of money. The sum of money to the 16 year old's recollection was approximately

\$5,000.00. The man described the 'work' as escorting other men on dates and working at a club that was intended for men to have sexual relations with the 16 year old.

- The 16 year old explained to the man offering the 'work' that she had no idea this was the work intended, that she would never say anything about the man or his helpers, would return all the money immediately given to her if they would let her go, and would let them know if she met other people that were interested in such 'work'.
- The money was returned and the 16 year old was let go to 'work' off her bus ticket by leading more youth to the man to 'work' for him.
- The 16 year old told other homeless youth about the money and the work under threat of harm to herself if she refused.
- The 16 year old then became homeless on the streets of San Francisco staying at various homeless youth shelters.
- The 16 year old became addicted to heroin and was sexually assaulted and beaten on many separate occasions by the men and their associates sporadically when she failed to provide them with more youth.
- The now 17 year old fled San Francisco to Los Angeles where she continued to be homeless and on the streets.
- The now 17 year old overdosed on heroin in Los Angeles and was sent to a local youth shelter who returned her to Ann Arbor, Michigan to live with a family friend.
- The entire time from removal to the time the 16 year old turned 18 the State of Michigan FIA did nothing more than provide bare minimum supervision or engagement of the minor child.
- They failed to protect the Minor Child from predators and sexually trafficking.
- They failed to report the Minor Child a runaway or endangered youth.
- They failed to provide the Minor Child with any support services within her community common today such as therapies, sibling contact, case management, educational opportunities or service that would have protected her.
- The child aged out of care homeless, addicted to heroin, and further traumatized.
- The child is now an adult and suffers from severe PTSD
- The child went on to become a relative provider to her youngest sibling
- The child is now a leading advocate for abused children and their tribes in the State of Alaska
- The child is now a licensed foster home in the State of Alaska
- The child is now a wonderful mother to one child.
- The child would like to state that children who are removed should not be placed in worse circumstances than what they were removed from.
- The child would like to state that across states and Departments there is little to no accountability for front line or child protective workers due to confidentiality of CINA cases and the various Departments' own efforts to minimize knowledge of their horrific care of foster children. There is no branch save CINA court that can enforce dereliction of duty and that is rare as the general view is that anything is good enough for a foster child.
- The Department's goal should have been family preservation and services offered to keep the children and their parents together; had it been the child would not have been human trafficked under State care because the child had no business being in State care to begin with.

We adopted children from Foster care in Nevada, and it was the worst experience of our lives. The corruption within the system with the government employees is horrible. We have audio recordings, documents, etc. But the corruption goes up through supervisors and management.

Employees here are getting kickbacks for everything. From referring (read: forcing parents to use) specific therapists for the kids to employees adopting infants from the system themselves, and preventing wealthy well-educated parents from adopting. They actively tried to prevent us from being licensed several times. We were flat out told we were "not controllable", we "asked too many questions" and were "too educated", so they would be delaying our license indefinitely.

We went all the way up the ladder, and they finally licensed then released our home-study from Southern Nevada. So, we could try to adopt from Foster Care outside of the state. We were determined to save children from this system... but we were not allowed to adopt here.

We did eventually adopt from Northern Nevada, and due to the corruption down here in Southern Nevada, the case workers in northern Nevada fought to keep the case until the adoption was official. Due to corruption the poor northern Nevada caseworkers were always having to step in and remove agents from southern Nevada that were assigned to "supervise".

This office is so corrupt a couple of years ago they brought in a specialist to try to remove the corruption, and they made it impossible for them to accomplish anything. There's one willing whistle-blower working there, but only if they can talk behind the scenes off location.

This office is up to something more than kickbacks on services. They are so tight-lipped. Everyone new gets framed immediately if they don't go along with "the program", and all high class well educated parents interested in fostering or adopting are discouraged or prevented from being licensed.

Good luck! I've never seen a more corrupt system...

...aside from the toxic chemical poisoning of our nations food (pesticides, bleach, etc.) and water (fluoride, chlorine, etc.) supplies.

...aside from the power company lobbying to prevent home owners from using solar... in Vegas... unless you sign the lease contract only receiving a discount on your power, and sticking you with a bill at the end of the lease to remove the equipment.

....aside from the corporate propaganda being advertised in the public school workbooks, and the banning of allowing parents to view workbooks before topics are covered in school. (Really. In Nevada the schools won't let the parents view the workbooks, even if you request through the principal, and offer to pay for copies. Pages are torn out and only certain pages are sent home with the students after they have been taught. Note: Not all, only certain pages. So, many missing numbered pages.)

When the government partners with private industry, corruption is soon to follow.

The privatization of foster care created a lucrative and competitive industry and children became a commodity.

The industry, protected by the secrecy of the family court system, has become so corrupt and powerful, it has no regard for facts, evidence or due process of the law. This has resulted in 1000s of children being swept into the foster care system for profit. It attracts not only those seeking a pay check from the government, but also those seeking sexual gratification from children.

The very first thing we must do is remove the veil of secrecy in family court. Hearings should be open and public. Judges routinely issue gag orders of parents to prevent them from exposing the violation of their rights.

In 96% of DCF cases, allegations of abuse or neglect by parents is unsubstantiated yet these children are removed from the home anyway. Many are placed with strangers and sexually and physically abused, even murdered. Many disappear without a trace.

Protect families at the court level by affording them the same due process and civil rights afforded to those accused of a crime.

Judges should not be signing removal warrants unless DCF investigations can produce evidence substituting abuse or neglect which is likely to result in death or injury.

Parents should be permitted to question their accusers. As it is, parents are rarely allowed to speak in court. These hearings should be public. Family court pretends that, because of privacy issues, children's identities should be protected. However, in criminal court, in cases of abuse of children, the court identifies children by their initials and this is sufficient protection.

If the federal and state government will address the issue of false allegations, violations of due process, far fewer children will be taken in to the foster care system, thus protecting them from abuse by foster 'pretenders' and sex traffickers.
