FY2015 Family Violence Prevention & Services Act (FVPSA) Awards to States and Territorial Coalitions

The Family Violence Prevention & Services Program in the Family Youth & Services Bureau administers the Family Violence Prevention & Services Act (FVPSA) funding, the only source of dedicated funding for domestic violence shelter and supportive services since 1984. In FY2015, the appropriation for FVPSA was \$135 million.

\$13.5 million or 10% of FVPSA funds will be awarded to 56 domestic violence coalitions to expand and enhance statewide and territorial responses to domestic violence victims and organizations with an emphasis on systems reform, public policy, training and technical assistance, prevention, and public awareness. Grantees will each receive awards of \$241,000.
