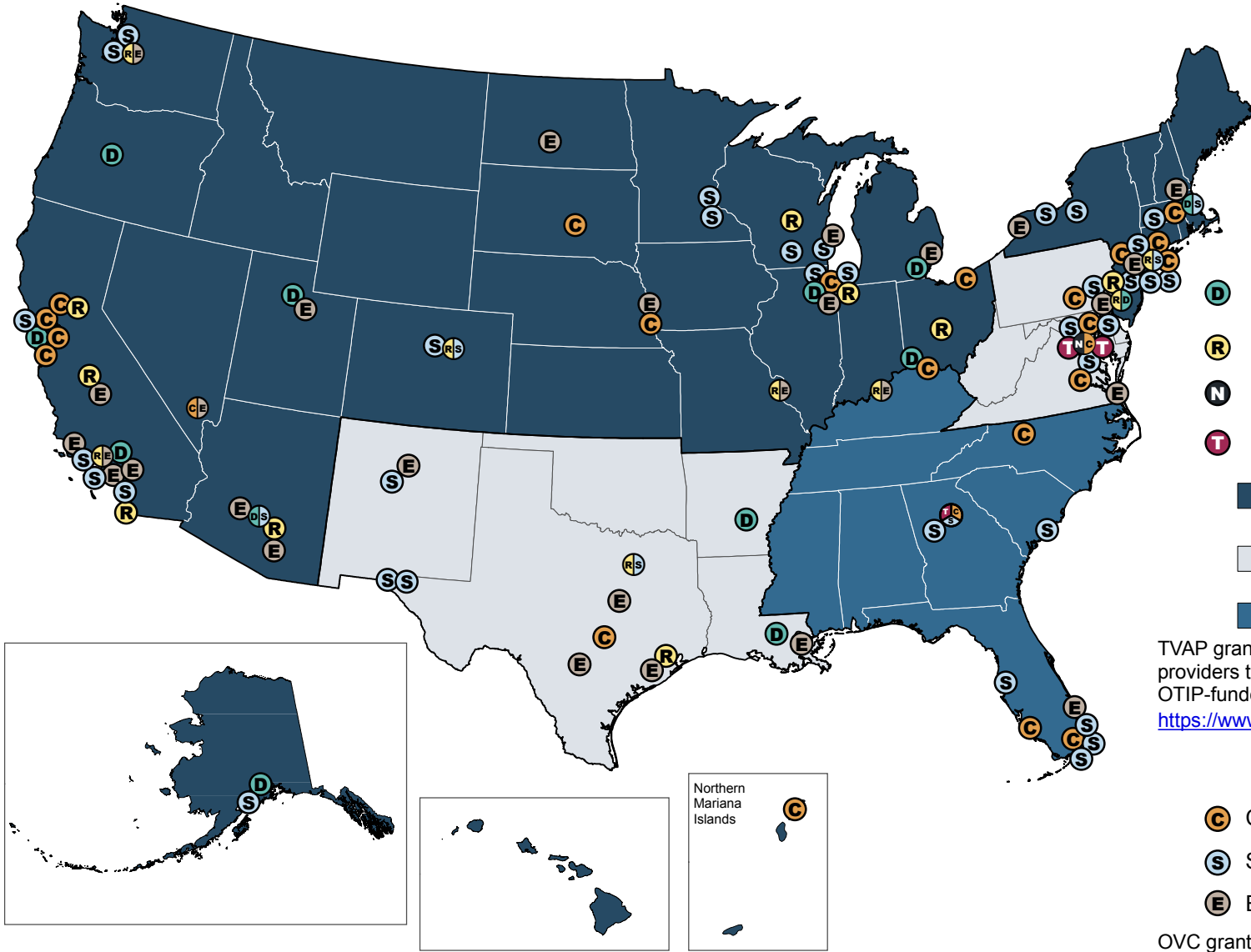


Map of Office on Trafficking in Persons (OTIP) Program Grantees and Office for Victims of Crime (OVC) Human Trafficking Grantees
