

POWER OF ATTORNEY

I the undersigned, _____, **bearer of** American Social Security Number _____ of _____ (address), hereby appoint Advocates _____ (all jointly and severally) to be my Attorney/s in the matter of dealing with the enforcement of a Foreign Judgment;

Without prejudice to the generality of the said appointment my Attorney/s may do and may act in my name and instead of me in relation some or all of the following actions and all in connection with the aforementioned matter and in relation to all matters arising from it, as follows:

1. To sign and submit on my behalf any claim or counter-claim and/or any application, defense, objection, application for leave to appeal, appeal, judicial review, notice, argument, reservation, challenge, action or any other proceeding pertaining to or arising from the aforementioned proceeding without exception, and without prejudice to the foregoing, also to make any admission or a denial in criminal trials.
2. To sign and/or send notarized or other warnings, to apply for a declaration of bankruptcy or the winding up of a legal body and do all such acts as are connected with and arise from the aforementioned matter.
3. To request and obtain any medical expert opinion and/or other medical document from any doctor or institution that has examined me and/or any other expert opinion in relation to the aforementioned matter.
4. To represent me and appear on my behalf and instead of me in connection with any of the aforementioned actions before any Courts, Tribunals of any kind, Government or Municipal Authorities, Local Authorities and/or any other Authority up to the final instances thereof, in so far as such matters pertain to or are connected with the aforementioned matter.
5. To take all such actions as are involved in the aforementioned representation and as are permitted under the existing Rules of Procedure or those that shall be applicable in the future and including the summoning of witnesses and appointment of experts, and all in accordance with the Law that shall be applicable at the time and as my Attorney shall deem appropriate.
6. To refer any matter arising from the aforementioned matter to arbitration and to sign an arbitration agreement as my Attorney shall deem appropriate.
7. To enter into a compromise settlement in any matter pertaining to or arising from the aforementioned matters at the discretion of my Attorney and sign such a compromise settlement either in or out of Court.
8. To execute any judgment or decision or order, to apply for sale orders or arrest warrants and take all such actions as are permitted under the Execution Law and to act in accordance with its Regulations.

9. To take all such actions and sign any document or instrument without exception as my Attorney shall deem appropriate in any matter arising from and/or pertaining to the aforementioned matter.
10. To request and receive information that I am entitled to receive under any Law from any database of any Authority pertaining to the aforementioned matter.
11. To appear on my behalf and to represent me in the aforementioned matter before the Land Registrar, at the Offices of the Land Registry, to sign on my behalf and in place of me any application, declaration and other documents of any nature and to implement on my behalf any transaction that is recognized by Law and to give declarations, receipts and certifications and receive on my behalf and instead of me any document that I am entitled to receive by Law.
12. To represent me and appear on my behalf before the Registrar of Companies, the Registrar of Partnerships and the Registrar of Cooperative Societies, to sign on my behalf and instead of me any application or other document in connection with the registration of a legal body, to deal with the registration of it or the striking off of any legal body and to deal with any matter pertaining to it and perform any action in connection with such legal body.
13. To deal on my behalf with all matters connected with registration of patents, trademarks and other legally recognized rights.
14. To transfer this Power of Attorney and all the powers contained herein or some of them to another Advocate with a right of transfer to others, and to dismiss them and appoint others instead of them and conduct the aforementioned matters as they shall see fit and including taking all such steps as are deemed necessary and beneficial in connection with the trial or with the aforementioned matters and I hereby ratify his actions or the actions of those acting on his behalf in advance pursuant to this Power of Attorney.

Whatever is stated above in the singular shall also include the plural and vice-versa.
